An Act to amend *The Saskatchewan Watershed Authority Act, 2005*
and to make consequential amendments to other Acts

(Assented to _____)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

Short title

1 This Act may be cited as *The Saskatchewan Watershed Authority Amendment Act, 2012*.

2 *The Saskatchewan Watershed Authority Act, 2005* is amended in the manner set forth in this Act.

New chapter number and long title

3 **The chapter number and long title are repealed and the following substituted:**

“CHAPTER W-8.1

An Act respecting Water Rights and the Water Security Agency”.

New section 1

4 **Section 1 is repealed and the following substituted:**

“Short title

1 This Act may be cited as *The Water Security Agency Act”*.

Section 2 amended

5 **Clause 2(b) is repealed and the following substituted:**

“(b) ‘**corporation**’ means the Water Security Agency continued pursuant to section 3”.

New heading

6 **The heading before section 3 is struck out and the following substituted:**

“PART II

Water Security Agency”.

New section 3

7 **Section 3 is repealed and the following substituted:**

“Corporation continued

3(1) The Saskatchewan Watershed Authority is continued as the Water Security Agency.

(2) The corporation is a Treasury Board Crown corporation within the meaning of *The Crown Corporations Act, 1993*.

(3) A reference in any order, bylaw, contract, legal process, proceeding or other document or instrument to the Saskatchewan Watershed Authority is deemed to be a reference to the Water Security Agency”.

Consequential amendments

8 The provisions of the Acts set out in Table 1 of the Schedule are amended by striking out “*The Saskatchewan Watershed Authority Act, 2005*” wherever it appears and in each case substituting “*The Water Security Agency Act*”.

(2) Subsection 130(1) is amended by striking out “the Saskatchewan Watershed Authority” and substituting “the Water Security Agency”.

(3) Subsection 185(1) is amended by striking out “the Saskatchewan Watershed Authority” and substituting “the Water Security Agency”.

(4) Subsection 185(6) is amended by striking out “the Saskatchewan Watershed Authority” and substituting “the Water Security Agency”.

13 Clause 2(b) of *The Water Appeal Board Act* is repealed and the following substituted:

“(b) ‘**corporation**’ means the Water Security Agency continued pursuant to *The Water Security Agency Act*”.

14 Clause 2(a) of *The Water Power Act* is repealed and the following substituted:

“(a) ‘**corporation**’ means the Water Security Agency continued pursuant to *The Water Security Agency Act*”.
