An Act making consequential amendments to certain Acts resulting from the enactment of *The Proceedings Against the Crown Act, 2018*

(Assented to _____)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

Short title

1 This Act may be cited as *The Proceedings Against the Crown Consequential Amendments Act, 2018*.

2 Subsection 111(3) of *The Correctional Services Act, 2012* is repealed.

SS 1990-91, c F-22.01, section 23 amended

3 Clause 23(3)(g) of *The Freedom of Information and Protection of Privacy Act* is repealed and the following substituted:

“(g) section 11 of *The Proceedings Against the Crown Act, 2018*”.

Schedule

4 The provisions listed in Schedule 1 are amended by striking out “*The Proceedings against the Crown Act*” and substituting “*The Proceedings Against the Crown Act, 2018*”.

Coming into force

5 This Act comes into force on the day on which section 1 of *The Proceedings Against the Crown Act, 2018* comes into force.
