## An Act to amend *The All Terrain Vehicles Act*

(Assented to \_\_\_\_\_)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

### Short title

1 This Act may be cited as *The All Terrain Vehicles Amendment Act, 2020*.

### SS 1988-89, c A-18.02 amended

2 *The All Terrain Vehicles Act* is amended in the manner set forth in this Act.

### Section 2 amended

3 **Subclause 2(1)(b)(ii) is repealed and the following substituted:**

“(ii) has wheels or tracks in contact with the ground”.

### Section 5 amended

4 **Section 5 is amended:**

(a) **in clause (b) in the portion preceding subclause (i) by striking out “but under the age of 16 years,”;**

(b) **in subclause (b)(vi) by striking out “board” and substituting “administrator”; and**

(c) **in subclause (c)(iii) by striking out “board” and substituting “administrator”.**

### Section 7 amended

5 **Clause 7(2)(a) is amended by striking out “board” and substituting “administrator”.**

### Section 8 amended

6(1) **Subsection 8(1) is amended by striking out “board” and substituting “administrator”.**

(2) **Subsection 8(2) is amended by striking out “board” wherever it appears and in each case substituting “administrator”.**

### Section 10 amended

7(1) **Subsection 10(1) is amended in the portion preceding clause (a) by striking out “board” and substituting “administrator”.**

(2) **Subsection 10(2) is amended by striking out “board” and substituting “administrator”.**

**Section 12 amended**

**8 Subsection 12(2) is amended by striking out “board” and substituting “administrator”.**

**Section 20 amended**

**9 Clause 20(1)(e) is amended by striking out “board” and substituting “administrator”.**

**Section 26 amended**

**10 Subsection 26(1) is amended by striking out “board” wherever it appears and in each case substituting “administrator”.**

**Section 27 amended**

**11 Section 27 is amended by striking out “board” wherever it appears and in each case substituting “administrator”.**

**Section 28 amended**

**12(1) Subsection 28(1) is amended by striking out “board” and substituting “administrator”.**

**(2) Subsection 28(3) is amended by striking out “the board may furnish the administrator and” and substituting “the administrator may provide a”.**

**(3) Subsection 28(4) is amended:**

**(a) by striking out “board” and substituting “administrator”; and**

**(b) by striking out “furnish” and substituting “provide”.**

**Coming into force**

**13 This Act comes into force by order of the Lieutenant Governor in Council.**
