An Act to amend *The Automobile Accident Insurance Act*

(Assented to _____)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

Short title

1 This Act may be cited as *The Automobile Accident Insurance Amendment Act, 2021*.

2 *The Automobile Accident Insurance Act* is amended in the manner set forth in this Act.

Section 15 amended

3 **The following subsection is added after subsection 15(3):**

“(4) Subsection (2) does not apply to a person whose driver’s licence or other permit to drive is suspended, cancelled or revoked and who is participating in:

- (a) driver training and is taking instruction from and is accompanied by a person who holds a valid driving instructor’s certificate issued pursuant to *The Traffic Safety Act*;
- (b) a road test and is accompanied by or under the direction of a person authorized pursuant to *The Traffic Safety Act* to conduct driver examinations; or
- (c) a driver assessment and is accompanied by either a person who holds a valid driver instructor’s certificate issued pursuant to *The Traffic Safety Act* or a person authorized pursuant to *The Traffic Safety Act* to conduct driver examinations”.

Section 35, statutory condition amended

4 **Section 35 is amended by adding the following after statutory condition 1.1:**

“1.2 Statutory Conditions 1 and 1.1(b) do not apply to a person whose driver’s licence or other permit to drive is suspended, cancelled or revoked and who is participating in:

- (a) driver training and is taking instruction from and is accompanied by a person who holds a valid driving instructor’s certificate issued pursuant to *The Traffic Safety Act*;
- (b) a road test and is accompanied by or under the direction of a person authorized pursuant to *The Traffic Safety Act* to conduct driver examinations; or
- (c) a driver assessment and is accompanied by either a person who holds a valid driver instructor’s certificate issued pursuant to *The Traffic Safety Act* or a person authorized pursuant to *The Traffic Safety Act* to conduct driver examinations”.

Section 39, statutory conditions amended

5(1) Section 39 is amended in the manner set forth in this section.

(2) Statutory condition 1.1 is amended in clauses (a) and (b) by striking out “*The Vehicle Administration Act*” and substituting “*The Traffic Safety Act*”.

(3) The following is added after statutory condition 1.1:

“1.2 Statutory Conditions 1.1, 2(1)(b) and 2(2)(b) do not apply to a person whose driver’s licence or other permit to drive is suspended, cancelled or revoked and who is participating in:

(a) driver training and is taking instruction from and is accompanied by a person who holds a valid driving instructor’s certificate issued pursuant to *The Traffic Safety Act*;

(b) a road test and is accompanied by or under the direction of a person authorized pursuant to *The Traffic Safety Act* to conduct driver examinations; or

(c) a driver assessment and is accompanied by either a person who holds a valid driver instructor’s certificate issued pursuant to *The Traffic Safety Act* or a person authorized pursuant to *The Traffic Safety Act* to conduct driver examinations”.

(4) Statutory condition 12(2) is amended by striking out “*The Saskatchewan Insurance Act*” and substituting “*The Insurance Act*”.

Section 41.15 amended

6 Clause 41.15(3)(d) is amended by striking out “as defined in *The Saskatchewan Insurance Act*” and substituting “within the meaning of *The Insurance Act*”.

Section 48, statutory conditions amended

7(1) Section 48 is amended in the manner set forth in this section.

(2) Statutory condition 1.2 is amended in clauses (a) and (b) by striking out “*The Vehicle Administration Act*” and substituting “*The Traffic Safety Act*”.

(3) The following is added after statutory condition 1.2:

“1.3 Statutory Conditions 1.2, 2(1)(b) and 2(2)(b) do not apply to a person whose driver’s licence or other permit to drive is suspended, cancelled or revoked and who is participating in:

(a) driver training and is taking instruction from and is accompanied by a person who holds a valid driving instructor’s certificate issued pursuant to *The Traffic Safety Act*;

(b) a road test and is accompanied by or under the direction of a person authorized pursuant to *The Traffic Safety Act* to conduct driver examinations; or

(c) a driver assessment and is accompanied by either a person who holds a valid driver instructor’s certificate issued pursuant to *The Traffic Safety Act* or a person authorized pursuant to *The Traffic Safety Act* to conduct driver examinations”.

(4) Statutory condition 7(2) is amended by striking out “*The Saskatchewan Insurance Act*” and substituting “*The Insurance Act*”.

Section 52 amended

8 Subsection 52(1) is amended:

- (a) in clause (b) by striking out “*The Saskatchewan Insurance Act*” and substituting “*The Insurance Act*”; and**
- (b) in clause (c):**
 - (i) by striking out “*The Saskatchewan Insurance Act*” and substituting “*The Insurance Act*”; and**
 - (ii) by striking out “section 204” and substituting “section 8-55”.**

Section 58 amended

- 9(1) Subsection 58(1) is amended by striking out “*The Saskatchewan Insurance Act*” and substituting “*The Insurance Act*”.**
- (2) Subsection 58(2) is amended by striking out “*The Saskatchewan Insurance Act*” and substituting “*The Insurance Act*”.**
- (3) Subsection 58(3) is amended by striking out “*The Saskatchewan Insurance Act*” and substituting “*The Insurance Act*”.**

Section 68 amended

- 10 Clause 68(3)(b.1) is amended by striking out “*The Vehicle Administration Act*” and substituting “*The Traffic Safety Act*”.**

Coming into force

- 11 This Act comes into force on assent.**
