An Act to make consequential amendments resulting from the enactment of *The Education Amendment Act, 2023*

(Assented to)

HIS MAJESTY, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

Short title

1 This Act may be cited as *The Education Consequential Amendments Act, 2023*.

RSS 1978, c M-26 amended

2(1) *The Municipal Employees' Pension Act* is amended in the manner set forth in this section.

(2) **The following subclause is added after subclause 2(r)(iii):**

“(iii.1) the SDLC as defined in *The Education Act, 1995*”.

(3) **Clause 2.1(1)(a) is amended in the portion preceding subclause (i) by striking out “or the conseil scolaire” and substituting “, the conseil scolaire or the SDLC”.**

3 **Subclause 2(g)(ii) of *The Public Works and Services Act* is amended by adding “, the Saskatchewan Distance Learning Corporation” after “the conseil scolaire”.**

SS 2015, c R-15.1, section 2 amended

4 **Section 2 of *The Registered Teachers Act* is amended:**

(a) **in clause (k) by adding “the SDLC,” after “the conseil scolaire,”; and**

(b) **by adding the following clause after clause (u):**

“(u.1) ‘SDLC’ means the SDLC as defined in *The Education Act, 1995*”.

5 **Section 2 of *The Teachers' Dental Plan Act* is amended:**

(a) **by adding the following clause after clause (e):**

“(e.1) ‘SDLC’ means the SDLC as defined in *The Education Act, 1995*”;

(b) **in subclause (f)(i) by striking out “or the conseil scolaire” and substituting “, the conseil scolaire or the SDLC”; and**

(c) **in clause (g) by adding “the SDLC” after “the conseil scolaire.”**

EDUCATION CONSEQUENTIAL AMENDMENTS ACT, 2023

RSS 1978, c T-8 amended

6(1) *The Teachers' Life Insurance (Government Contributory) Act* is amended in the manner set forth in this section.

(2) Section 1.1 is repealed and the following substituted:**“Definitions and interpretation**

1.1(1) In this Act:

(a) **‘board of education’** means a board of education as defined in *The Education Act, 1995*;

(b) **‘conseil scolaire’** means the conseil scolaire as defined in *The Education Act, 1995*; and

(c) **‘SDLC’** means the SDLC as defined in *The Education Act, 1995*.

(2) For the purposes of this Act, **‘teacher’** includes all persons employed on a full-time basis by a board of education or the conseil scolaire:

(a) who, pursuant to section 266 of *The Education Act, 1995* have been designated as not being teachers by The Educational Relations Board; and

(b) whose positions have been designated by the Teachers' Superannuation Commission as requiring the professional qualifications of a teacher”.

(3) Section 2 is amended:**(a) by repealing clause (a) and substituting the following:**

“(a) boards of education, the conseil scolaire and the SDLC with respect to all teachers employed on a full-time basis by a board of education, the conseil scolaire or the SDLC, as the case may be”;

(b) in clause (d.1) in the portion preceding subclause (i) by striking out “a board of education or the conseil scolaire as defined in *The Education Act, 1995*” **and substituting** “a board of education or the conseil scolaire”; **and**

(c) in clause (d.2) by striking out “or the conseil scolaire” **and substituting** “, the conseil scolaire or the SDLC”.

(4) Subsection 5(1) is amended by adding “or the SDLC with respect to the attendance area of the SDLC” **after** “conseils scolaires for francophone education areas”.

EDUCATION CONSEQUENTIAL AMENDMENTS ACT, 2023

(5) Section 7 is amended:**(a) in clause (a):**

(i) by striking out “a board of education or the conseil scolaire” **and substituting** “a board of education, the conseil scolaire or the SDLC”;

(ii) by striking out “the board of education or by the conseil scolaire” **and substituting** “the board of education, the conseil scolaire or the SDLC”; **and**

(iii) by striking out “the board of education or the conseil scolaire” **and substituting** “the board of education, the conseil scolaire or the SDLC”; **and**

(b) in clause (b) by striking out “or to the conseil scolaire” **and substituting** “, the conseil scolaire or the SDLC, as the case may be”.

(6) Section 8 is amended by striking out “or the conseil scolaire” and substituting “, the conseil scolaire or the SDLC”.**(7) Subsection 11(2) is amended:****(a) in clause (b):**

(i) by striking out “any board of education or the conseil scolaire” **and substituting** “any board of education, the conseil scolaire or the SDLC”; **and**

(ii) by striking out “the board of education or the conseil scolaire” **and substituting** “the board of education, the conseil scolaire or the SDLC”; **and**

(b) in clause (e) by adding “the SDLC” **after** “the conseil scolaire.”.

7 Clause 2(1)(l) of *The Teachers Superannuation and Disability Benefits Act* is amended by adding the following subclause after subclause (ii):

“(ii.1) the SDLC as defined in *The Education Act, 1995*”.

SS 2013, c W-17.11, section 2 amended

8 Subclause 2(1)(l)(v) of *The Workers’ Compensation Act, 2013* is repealed and the following substituted:

“(v) a school board, the conseil scolaire and the SDLC”.

9 This Act comes into force on the day on which section 1 of *The Education Amendment Act, 2023* comes into force.
