- (1) Yes.
- (2) The main purpose of trade missions is to generate awareness of Saskatchewan's attractiveness as an investment destination. The private sector has consistently been a supportive and willing participant. There were a number of positive outcomes for the Ministry of Energy & Resources. Following the 2010 trade mission to China and Japan, Long Fortune Petroleum Corporation opened a Regina office in May 2010. CanaSea Low-Carbon Inc. has also set up an office in Regina. Following a February 1 meeting with Sinofert, a potash sale was announced on February 8. Then on October 10, Canpotex entered into a new three-year Memorandum of Understanding (MOU) with Sinofert. The MOU covers a minimum of 3.15 million tonnes of potash over the three-year period, with prices to be negotiated every six months based on market conditions. Zhong Chuan International Mineral Holdings Co., Ltd. has invested over \$10 million in Saskatchewan's mining sector over the past three years. Investment attraction is a long term undertaking, and this year's mission will help ensure Zhong Chuan remains active in Saskatchewan. It is reasonable to expect additional investment in future. Additional missions will

be undertaken to continue the process of making Saskatchewan better known to potential investors.
