QUESTIONS AND ANSWERS

The following responses to written questions were tabled by the government:

Question no. 251 (Ms. Sproule):

To the Minister Responsible for the Saskatchewan Power Corporation: (1) How much revenue was generated through SaskPower's Carbon Capture and Storage (CCS) global consortium for each membership level in 2013? (2) 2014? (3) 2015? (4) 2016?

Answer:

There have been no revenues generated through the CCS consortium through the period ending December 31, 2016. As a result of relationships established through the consortium, a partnership with BHP Billiton was negotiated with a commitment of \$20M over five years to fund the International CCS Knowledge Centre. The partnership was formally announced on February 5, 2016.

Question no. 252 (Ms. Sproule):

To the Minister Responsible for the Saskatchewan Power Corporation: (1) What were SaskPower's total costs associated with SaskPower's CCS symposiums in 2013? (2) 2014? (3) 2015? (4) 2016? Answer:

SaskPower CCS symposiums were held in 2013, 2014, and 2015.

\$189,000	\$166,327	\$4,479	\$0

Note: In 2015 a joint event was held with the international energy agency greenhouse gas program (IEAGHG) post combustion capture conference in which costs were offset with sponsorship.

Question no. 253 (Ms. Sproule):

To the Minister Responsible for the Saskatchewan Power Corporation: (1) How many memberships (of each level) to SaskPower's CCS global consortium were sold in 2013? (2) 2014? (3) 2015? (4) 2016?

Answer:

No memberships have been sold through the CCS consortium through the period ending December 31, 2016. SaskPower began communicating a potential CCS consortium framework in the late months of 2012 through 2015. From late 2015 a partnership opportunity with BHP Billiton was negotiated with a commitment of \$20M over five years to fund the International CCS Knowledge Centre. The partnership was formally announced on February 5, 2016.

Question no. 254 (Ms. Sproule):

To the Minister Responsible for the Saskatchewan Power Corporation: What is the Saskatchewan Power Corporation's current debt-to-equity ratio?

Answer:

SaskPower's debt-to-equity ratio as at February 28, 2017 was 75.7%.

Question no. 255 (Ms. Sproule):

To the Minister Responsible for the Saskatchewan Power Corporation: (1) Since March 31, 2016, how many megawatts (MW) of capacity has been generated by the Cypress wind power facility? (2) SunBridge wind power facility? (3) Centennial wind power facility? (4) Morse wind energy facility? (5) Red Lily wind energy facility?

Answer:

The installed capacity (in MW) of each facility allows electricity to be generated and supplied to the grid when the wind is blowing. This energy is measured in megawatt-hours (or MWh). One MWh is equal to 1000 kilowatt hours (or KWh).
