QUESTIONS AND ANSWERS

The following responses to written questions were tabled by the government:

Question no. 97 (Ms. Sarauer):

To the Minister of Corrections and Policing, what are the hours of operation for each crime reduction team in each location?

Answer:

Crime reduction teams are able to modify or extend hours of operation as operational needs require.

Question no. 98 (Ms. Sarauer):

To the Minister of Corrections and Policing, how many commercial vehicle inspectors did not pass the additional training for the provincial response team?

Answer:

The Ministry of Corrections and Policing is not the ministry responsible for the commercial vehicle inspectors.

Question no. 100 (Ms. Sarauer):

To the Minister of Corrections and Policing, what upgrades and renovations are planned for correctional centres in the 2019–2020 fiscal year?

Answer:

Paul Dojack Youth Centre:

- (a) 14-bed unit new build
- (b) Cultural centre completion
- (c) Design work for upgrading locks and security infrastructure

Kilburn Hall Youth Centre

- (a) Ventilation upgrade and new kitchen equipment in the kitchen
- (b) Washroom upgrades

Pine Grove Correctional Centre

- (a) Medical unit expansion
- (b) Laundry expansion
- (c) Cultural Centre new build
- (d) Design work for upgrading locks and security infrastructure
- (e) Fencing

Saskatoon Correctional Centre

- (a) Locks and security infrastructure project
- (b) Body scanner and drug loo
- (c) Fencing
- Prince Albert Correctional Centre

Question no. 101 (Ms. Sarauer):

To the Minister of Corrections and Policing, (a) does the provincial government receive any commission through its contracts with Telmate, (b) if so, what is the commission structure, and (c) how much has the provincial government received since the contract was signed?

Answer:

- (a) The provincial government does receive commissions through its contract with Telmate.
- (b) The commission amount is 10% and \$1,300 for a monthly service fee.
- (c) The provincial government has received \$1,151,628, however, this amount has been deposited into the offender's collective trust bank account.

Question no. 102 (Ms. Sarauer):

To the Minister of Corrections and Policing, (a) does the provincial government receive any commission through its contracts with Compass Group Canada, (b) if so, what is the commission structure, and (c) how much has the provincial government received since the contract was signed?

Answer:

- (a) The provincial government does receive commissions through its contract with Compass Group Canada.
- (b) The commission amount is 10% of the commission sales excluding GST.
- (c) The provincial government has received \$461,980 however, this amount has been deposited into the offender's collective trust bank account.

Question no. 103 (Ms. Sarauer):

To the Minister of Corrections and Policing, for each Saskatchewan correctional facility, what is the wait time to see each type of medical specialist in the past fiscal year?

Answer:

Wait times vary depending on the availability of the service provider in each community.

Prince Albert Correctional Centre

- General practitioner 1 to 2 weeks
- Psychiatry 1 to 2 weeks
- Optometry 24 weeks
- Dental 1 to 3 weeks
- Harm reduction 0 hours per week

Pine Grove Correctional Centre

- General practitioner 3 weeks
- Psychiatry 8 to 12 weeks
- Optometry None
- Dental 8 to 12 weeks
- Methadone each client seen (1 per month)

Regina Correctional Centre

- General practitioner 2.4 weeks (Regina Correctional Centre/few days at White Birch Remand Centre)
- Psychiatry 12 to 16 weeks
- Optometry 8 weeks if they qualify, 12 + weeks if they don't meet criteria
- Dental 8 to 12 weeks
- Harm reduction 0
- Methadone seen next clinic after admission
- Phlebotomy 2 weeks
- Sexual transmitted infection clinic no waitlist

Saskatoon Correctional Centre

• General practitioner — 1 to 2 weeks

- Psychiatry 6 to 8 weeks
- Optometry 12 to 16 weeks
- Dental 24 to 28 weeks
- Harm reduction 4 to 8 weeks
- Methadone 0

Question no. 104 (Ms. Sarauer):

To the Minister of Corrections and Policing, what is the status of the justice access centre which planned for the Weyburn court house, and the Saskatoon provincial court house?

Answer:

The Ministry of Corrections and Policing is not responsible for the justice access centres which are planned for Weyburn court house and Saskatoon provincial court house.
