QUESTIONS AND ANSWERS

The following response to a written question was tabled by the government:

Question no. 98 (Mr. Pedersen):

To the Minister of Agriculture, with respect to the Ministry of Agriculture's revenue listed under other own source revenue in public accounts, what categories or types of fees and charges make up the other fees and charges and the miscellaneous subcategories?

Answer:

Other fees and charges revenue consists of lease revenue, land sale revenue pesticides licenses, resource considerations, crop lab fees, meat inspection fees, Ag implement dealer licenses, irrigation soil certification fees, game farm ear tags, and fur farm licenses.

Miscellaneous revenue consists of gain on sale of land, refund of prior year's expense — primarily the result of the over-accrual AgriStability program expense in 2017–18 and a refund of prior years' research grant payments, casual revenue — primarily under Lands branch.

QUESTIONS ORDERED FOR RETURN

The following written questions were converted and orders for return were issued:

Return no. 72 (Mr. Pedersen):

To the Minister of Finance, for each year since 2009, the number of Canadian-controlled private corporations that reported net income in Saskatchewan of (a) less than \$100,000, (b) between \$100,000 and \$200,000, and (c) over \$200,000.

Return no. 73 (Mr. Pedersen):

To the Minister of Finance, for each year since 2009, the number of Canadian-controlled private corporations that had income in Saskatchewan that was ineligible for the small business deduction.

Return no. 74 (Mr. Pedersen):

To the Minister of Environment, if all discharges reported to the ministry in the past 6 years pursuant to section 9 of *The Environmental Management and Protection Act, 2010* have been recorded in Sask Spills.

Return no. 75 (Mr. Pedersen):

To the Minister of Environment, in each of the past 6 years, the number of discharges reported pursuant to section 9 of *The Environmental Management and Protection Act, 2010* that relate to hazardous substances discharged into a domestic sewer system.

Return no. 76 (Mr. Pedersen):

To the Government, if the Government of Saskatchewan has an inventory or records of how much asbestos cement pipe is used in municipal water main systems in the province.

Return no. 77 (Mr. Pedersen):

To the Government, the municipalities that use asbestos cement for water mains in the province.

Return no. 78 (Mr. Pedersen):

To the Government, (a) the total number of asbestos cement water main breaks in the province this year (2019 to date), (b) the location of the break, (c) if the government tests for asbestos levels in water anywhere in the province, (d) if the Government of Saskatchewan requires that municipal governments test for asbestos levels in water and, (e) if so, the process.

Return no. 79 (Mr. Pedersen):

To the Government, (a) the studies the government has conducted or commissioned on the health impacts of ingested asbestos, (b) the studies the government has conducted or commissioned on the health impacts of asbestos in municipal water supplies, and (c) the studies on the health impacts of ingested asbestos the government is aware of.

Return no. 80 (Mr. Pedersen):

To the Minister of Health, (a) if the government tracks the incidents of benign intestinal polyps in Saskatchewan, (b) if the government tracks the incidents of mesothelioma, (c) if the government tracks the incidents of mesothelioma that does not appear to be related to known asbestos exposure, (d) if the ministry is aware the United States regulates asbestos in water because ingested asbestos has been linked to cancer, and (e) if so, how this information has been incorporated into policy.

Return no. 81 (Mr. Pedersen):

To the Minister of Environment, with respect to the Ministry of Environment's revenue listed under other own source revenue in public accounts, the categories or types of fees and charges that make up the other fees and charges and the miscellaneous subcategories.
