**STATEMENT BY THE SPEAKER
(Unparliamentary Language)**

Yesterday, March 4, 2020 the Government House Leader (Hon. Mr. Harrison) raised a point of order asserting that during Question Period, the Member for Athabasca (Mr. Belanger) used profane language directed at the Premier (Hon. Mr. Moe). In response to the point of order, the Opposition House Leader (Ms. Sproule) stated that she had not heard the remark. I also did not hear the remark. I reviewed the audio-video of the proceedings and found there was nothing discernible on the record. Accordingly, it is impossible for me to rule on this matter.
