QUESTIONS ORDERED FOR RETURN

The following written questions were converted and orders for return were issued:

Return no. 91 (Ms. Sproule):

To the Minister of Environment, the number of tickets that were issued for angling without a license in the southern zone on May 4, 2019.

Return no. 92 (Ms. Sproule):

To the Minister of Labour Relations and Workplace Safety, according to WCB (Workers' Compensation Board), (a) the number of days in total the health sector (code G22) has lost in each of the last five years due to injury claims, (b) the number of days in total that have been lost this year due to COVID-19 related injuries, (c) the number of injury claims in total that have been filed this year due to COVID-19, (d) the number of injury claims in total that have resulted in days lost this year due to COVID-19, (e) the number of workplace deaths in total that have occurred this year due to COVID-19? (f) the number of days the health sector (code G22) has lost this year due to COVID-19 related injuries, (g) the number of days the retail sector (codes C32/33/41) has lost this year due to COVID-19 related injuries, (h) the number of days the construction sector (codes B11/12/13) has lost this year due to COVID-19 related injuries, (i) the number of days the transportation sector (code T42) has lost this year due to COVID-19 related injuries, and (j) the number of days the community and social services sector (codes S21) has lost his year due to COVID-19 related injuries.

To the Minister of Social Services, (a) how many income support clients received the one-time \$50 benefit for Social Services clients, (b) what was the total value of these payments, and (c) was there any overpayments as a result of the one-time payments?

Question no. 114 (Ms. Sproule):

To the Minister of Social Services, for each month since June 2019, (a) how many Saskatchewan assured income for disabilities (SAID) recipients were there, (b) how many new SAID clients were there, (c) how many SAID client cases were closed, (d) how many Saskatchewan assistance program (SAP) recipients were there, (e) how many new SAP clients were there, (f) how many SAP client cases were closed, (g) how many transitional employment allowance (TEA) recipients were there, (h) how many new TEA clients were there, (i) how many TEA client cases were closed, (j) how many Saskatchewan income support (SIS) recipients were there, (k) how many new SIS clients were there, and (l) how many SIS client cases were closed?
