**The Chair:** — All right, I would like to bring the Board of Internal Economy to . . . We will start at 11 a.m. here, October 23rd, 2019. And you have a proposed agenda in front of you. **Some Hon. Members:** — Agreed.

**The Chair:** — Carried. All right, let us go to item no. 1, which is an amendment to directive 13.1. Yes, you want me to read the motion?

**Ms. Sproule:** — We've seen it but . . .

**The Chair:** — Oh, you've seen it.

**Hon. Mr. Harrison:** — I can move it. I'll put the motion on the Table.

**The Chair:** — Okay, thanks.

**Hon. Mr. Harrison:** — Thank you very much, Mr. Speaker. There's been discussion between the parties, and I believe there will be agreement for the following motion, which reads:

That directive #13.1 be amended as follows:

Clause 7 is amended by adding "(c) is elected as a federal Member of Parliament or appointed to the Senate of Canada during the period of transition"; and,

That this amendment is effective October 21, 2019.

**The Chair:** — Okay. The motion as read, do I have somebody to move that motion?

**Hon. Mr. Harrison:** — I've signed it already.

**The Chair:** — Oh, you've already signed it.

**Hon. Mr. Harrison:** — Jumped the gun.

**The Chair:** — You've already signed it. Mr. Harrison has moved the motion. Can I have a seconder? Ms. Sproule. All in favour?

**Some Hon. Members:** — Agreed.

**The Chair:** — Carried. Okay, item no. 2 is resume consideration of agenda item 11 for the meeting 5/19, October 21st, 2019, recruitment for the position of Advocate for Children and Youth. Discussion or in camera or what are we looking at?

**Ms. Beck:** — It seems appropriate to have the discussion in

camera.

**The Chair:** — Okay. I need somebody to move that we'll go into camera.

**Mr. Weekes:** — I so move.

**The Chair:** — Mr. Weekes. Somebody to second. Ms. Beck. All in favour?

**Some Hon. Members:** — Agreed.

**The Chair:** — The Board of Internal Economy moves in camera 11:04 a.m.

**The Chair:** — Welcome back, everyone, to the Board of Internal Economy meeting. The board has decided to defer item 2 and item 3 to the call of the Chair. And item 4, the board has come up with a set date for the budget meeting of January 21st at 10 a.m.
