#### BOARD OF INTERNAL ECONOMY March 28, 2019

[The board met at 13:18.]

**The Chair:** — Okay, it now being 1:18 p.m. on March 28th, I bring the Board of Internal Economy meeting to order. We have with us MLA [Member of the Legislative Assembly] Dan D'Autremont, MLA Greg Brkich, Minister Jeremy Harrison, MLA David Forbes, and MLA Nicole Sarauer.

So I need someone to move the motion that the proposed agenda for meeting 2/19 be approved as presented ... [inaudible interjection] ... Is there something you want to strike? ... [inaudible interjection] ... Strike item 7?

Hon. Mr. Brkich: — Yes.

**The Chair:** — Okay, and 5(b). So with that amendment, can I have someone move the agenda as approved? Mr. Brkich. And a seconder? Mr. Forbes.

Somebody move that the minutes of meeting, January 19th, be adopted. Mr. Harrison. And someone to second that? Mr. Forbes.

Let's move to item no. 1 on our agenda. I wish to table the third quarter financial report 2018-2019 for the Legislative Assembly Service of Saskatchewan. I need someone to move that. Just tabling it, sorry. I'm just tabling. Item no. 2, tabling item. I wish to table the third quarter financial report 2018-19 for the Office of the Advocate for Children and Youth. And item no. 3, tabling item. I wish to table the third quarter financial report 2018-2019 for the Chief Electoral Officer, Elections Saskatchewan.

Okay, we're at item no. 4. I'm looking for a motion to move in camera. Minister Harrison. And somebody second to go in camera? Mr. Forbes.

[The board continued in camera from 13:22 until 13:31.]

**The Chair**: — Hello, everyone. It now being 1:31 p.m., we return, coming out of camera. We are at agenda item 4. Order, order. Agenda item no. 4. So go ahead, you can move it.

**Hon. Mr. Brkich**: — I have a motion to move:

## That Directive #21 be amended as follows:

- 1. Strike out the word "serious" in (c); and,
- 2. Clause 3 is also amended by adding "(g) Maternity/Paternity/Adoption Leave"; and,

# That this amendment is effective April 1st, 2019.

**The Chair:** — Move that? Can we have a seconder, please? Ms. Sarauer. All in favour?

Some Hon. Members: — Agreed.

**The Chair:** — Everyone is in favour. Okay, let's move on to item no. 5, which is the amendments to directive #3.1. Can I have a motion?

Hon. Mr. Harrison: — Sure. Thank you, Mr. Speaker. I would

move:

#### That Directive #3.1 be amended as follows:

Subclause 7(c) is amended by adding "(vi) Parking"; and,

That this amendment is effective January 1, 2019.

**The Chair:** — Can I have a seconder, please? Mr. Forbes. All in favour?

**Some Hon. Members**: — Agreed.

**The Chair:** — Everyone is in favour. All right, let's move on to item no. 6. I need someone to move:

#### That Directive #4.1 be amended as follows:

Clause (25) be amended by striking out "2018-19" and substituting "2019-20"; and,

#### That this amendment is effective April 1st, 2019.

Somebody move that, please.

**Mr. D'Autremont**: — I will.

**The Chair:** — Mr. D'Autremont. Seconder? Ms. Sarauer. All in favour?

**Some Hon. Members**: — Agreed.

**The Chair:** — Carried. All right. Let's move on to item no. 8, other business, decision item directive #3.1. Mr. D'Autremont.

**Mr. D'Autremont**: — I move:

### That Directive #3.1 be amended as follows:

Clause 5 is amended by adding "(f) travel outside of the province of Saskatchewan for courses taken where tuition is paid through an accredited/non-accredited Canadian/non-Canadian post-secondary educational institution": and,

# That this amendment is effective April 1, 2019.

I so move.

**The Chair:** — Can I have a seconder please? Mr. Forbes. All in favour?

Some Hon. Members: — Agreed.

**The Chair**: — Everyone's in favour. Any other business? Excellent. I need somebody to move adjournment of the board. Nicole Sarauer. Second? Mr. Harrison. All in favour?
