ITEM 2 Decision Item: Approval of the 2018-2019 Budget for the Legislative Assembly Service of Saskatchewan.

That Directive # 21 - Annual Indemnity and Allowances section (9) be amended as follows:

"(9) Notwithstanding Section (8), for fiscal year 2018-2019, the annual change is the Consumer Price index for Saskatchewan is deemed to be zero and the rates for annual indemnity and allowances as set out within this Directive shall remain unchanged."

And, that this amendment shall take effect on April 1, 2018 and shall lapse on March 31, 2019 unless extended by the Board of Internal Economy.
