Moved by Mr. Harrison, and seconded by Mr. Forbes;

That Directive #3.1 be amended by replacing clause 7 with a new clause 7 as follows:

"(7) Subject to clauses (8), (9), and (10), instead of clause (4)(e), with the required documentation, every Member who represents a constituency wholly outside of Regina has the option of claiming reimbursement for the accommodation expenses in the city of Regina at the rate schedule as set out by the National joint Council on January 1, 2017, for each day the private accommodation is available for the Member's occupancy and is not rented to any other person. Members may exceed the daily rate in any month but may only claim up to the maximum of \$18,250 annually for the reimbursement of accommodation expenses made in accordance with this

directive. In the event a Member resigns, retires or is defeated at the polls, any prepaid expense (i.e., property taxes, insurance, etc.) will be the personal responsibility of the Member to repay.

- (a) In the case of rental and leased accommodations, reimbursement must be for actual and reasonable expenses incurred to be supported by receipts in the following instances.
  - i. Rent;
  - ii. Contents insurance;
  - iii. Utilities;
- iv. Parking.
- (b) A Member may authorize the payment of rent directly to the landlord for rental and leased accommodations. Submission of a copy of the rental/lease agreement in the name of the Member is required.
- (c) In the case of owned accommodations, reimbursement must be for actual and reasonable expenses incurred to be supported by receipts and/or proof of payment in the following instances:
  - i. Property taxes;
  - ii. Mortgage interest;
  - iii. Insurance;
  - iv. Common element fees, if any;
  - v. Utilities.

(d) In the case of an owned accommodation, a Member may authorize the payment of expenses directly to a property manager or condo board.

All other expenses will be reimbursed upon the presentation of receipts and/or proof pf payment. Submission of documentation is required from a financial institution that identifies the mortgage principle and interest payable, as well as proof of payment, for reimbursement of mortgage interest payable on an accommodation owned by the Member."
