STANDING COMMITTEE ON CROWN AND CENTRAL AGENCIES June 13, 2014

[The committee met at 09:20.]

Mr. Park: — All right, good day, members. Since this is the first meeting of your committee since the resignation of your committee Chair, the first item of business today is the election of the Chair.

So I'd like to remind members of the process. I will first ask for nominations. Once there are no further nominations, I will ask a member to move a motion to have a committee member preside as Chair. I will now call for nominations for the committee Chair. Mr. Steinley.

Mr. Steinley: — I move:

That Herb Cox be elected to preside as Chair of the Standing Committee on Crown and Central Agencies.

Mr. Park: — All right, are there any further nominations? Seeing none, I will now invite one of the members to move that motion. Mr. Steinley.

Mr. Steinley: — I move:

That Herb Cox be elected as the Chair for the Standing Committee on Crown and Central Agencies.

Mr. Park: — All in favour of the motion?

Some Hon. Members: — Agreed.

Mr. Park: — All opposed? I declare the motion carried and invite Mr. Cox to take the Chair. Unfortunately Mr. Cox is not here today so we'll be looking to have an Acting Chair for today.

Although we have elected a new committee Chair, they're not able to be here today. As such, the committee will need to elect an Acting Chair for this meeting. So as the Committee Clerk, it is my duty to preside over the election. I will first ask for the nominations again, and once there are no further nominations, we'll move the motion. So I now call for nominations for the position of acting committee Chair. Mr. Steinley.

Mr. Steinley: — I move:

That Fred Bradshaw be elected to preside as Acting Chair of the Standing Committee on Crown and Central Agencies for June 13th, 2014.

Mr. Park: — All right. Mr. Steinley has nominated Mr. Bradshaw to the position of acting committee Chair. Are there any further nominations? Seeing none, I would now invite the member to move that motion. Mr. Steinley.

Mr. Steinley: — I move:

That Fred Bradshaw be elected to preside as Acting Chair of the Standing Committee on Crown and Central Agencies for the meeting of June 13th, 2014.

Mr. Park: — All in favour of the motion?

Some Hon. Members: — Agreed.

Mr. Park: — All opposed? The motion has been carried. I invite Mr. Bradshaw to take the Chair.

The Acting Chair (Mr. Bradshaw): — Thank you, committee members, for being here today — such a lovely day to spend a Friday on committee business.

At the present time we have: Rob Norris is authorizing Warren Steinley to attend the meeting for the Standing Committee on Crown and Central Agencies to substitute in; Cathy Sproule authorized Warren McCall to attend the meeting of the Standing Committee on Crown and Central Agencies today; Kevin Phillips authorizes Greg Ottenbreit to attend the meeting of the Standing Committee on the Economy today; and Wayne Elhard authorizes Fred Bradshaw to attend the meeting on the Standing Committee on Crown and Central Agencies today.

Seeing no further business, I would ask a member to move the motion of adjournment that Mr. Steinley has moved. All agreed?

Some Hon. Members: — Agreed.

The Acting Chair (Mr. Bradshaw): — Carried. This meeting stands adjourned till the call of the Chair.
