## STANDING COMMITTEE ON THE ECONOMY March 19, 2018

[The committee met at 09:52.]

Mr. Park: — All right. Good morning, everyone. My name is Rob Park, and this is the Standing Committee on the Economy. I am the Committee Clerk for this committee, and as such we have received a letter of resignation from the Chair, Mr. Buckingham. Since he has resigned as the Chair, it is my duty as the Committee Clerk to preside over the election of the new Chair.

I will first ask for nominations. Once there are no further nominations I'll ask a member to move the motion. Do I have any nominations for Chair? Mr. Bradshaw.

**Mr. Bradshaw**: — Yes. I would like to move:

That Colleen Young be elected to preside as Chair of the Standing Committee on the Economy.

Mr. Park: — Mr. Bradshaw has nominated and moved:

That Ms. Colleen Young be elected to preside as the Chair of the Standing Committee on the Economy.

All in favour of the motion?

Some Hon. Members: — Agreed.

Mr. Park: — Carried. Although we do have a committee Chair, she is not able to be here at the moment, so as such the Committee Clerk will need to elect an Acting Chair for the meeting. So as Committee Clerk, once again it is my duty to preside over the Acting Chair election.

I will ask for nominations; then after the nominations I will ask for a motion. Do I have any nominations for the Acting Chair? Ms. Carr.

**Ms. Carr**: — I'd like to move:

That Fred Bradshaw be elected to preside as Acting Chair of the Standing Committee on the Economy for the meeting of March 19th, 2018.

Mr. Park: — Thank you. Ms. Carr has nominated and moved:

That Mr. Fred Bradshaw be elected to preside as the Acting Chair of the Standing Committee on the Economy for the meeting of March 19th, 2018.

All in favour of that motion?

Some Hon. Members: — Agreed.

**Mr. Park**: — That motion is carried. Mr. Bradshaw, can you take the Chair please?

The Acting Chair (Mr. Bradshaw): — I would like to thank the committee members for the election. And now we have to do the election of the Deputy Chair; we will now proceed to an election of the Deputy Chair. Pursuant to rule 123(2), the Deputy Chair must be an opposition member unless specified in

the rules. Given that Ms. Mowat is the only member of the opposition on the committee, I will ask a member to move:

That Vicki Mowat be elected to preside as Deputy Chair of the Standing Committee on the Economy.

**Mr. McCall**: — Thanks, Mr. Acting Chair. I'd be very pleased to move the following motion as regards Ms. Mowat:

That Vicki Mowat be elected to preside as Deputy Chair of the Standing Committee on the Economy.

So moved.

The Acting Chair (Mr. Bradshaw): — Moved by Mr. McCall:

That Vicki Mowat be elected to preside as Deputy Chair of the Standing Committee on the Economy.

Is that agreed?

Some Hon. Members: — Agreed.

**The Acting Chair (Mr. Bradshaw)**: — Carried. Seeing that we have completed our business for today, I would ask a member to move a motion for adjournment. Greg Lawrence so moves. Is that agreed?

**Some Hon. Members**: — Agreed.

**The Acting Chair (Mr. Bradshaw)**: — Carried. This committee stands adjourned to the call of the Chair.
