## STANDING COMMITTEE ON HOUSE SERVICES June 13, 2014

[The committee met at 09:02.]

The Chair: — I'd like to call to order this meeting of the House Services Committee for June 13th, 2014 commencing at 9:02 a.m. Today we have one substitution. For Mr. Corey Tochor, we have Mr. Warren Steinley substituting in. Present as well is Mr. Fred Bradshaw, Mr. Greg Ottenbreit, Mr. Ken Cheveldayoff, Mr. Warren McCall, and Mr. David Forbes. As well, sitting in observing, we have MLA [Member of the Legislative Assembly] Gene Makowsky.

What we have on the agenda today is the consideration of membership changes on the standing committees. As well, I wish to inform the committee that I have received communications from a number of the members resigning their positions as chairpersons of various committees: from Ms. Nadine Wilson, her resignation as Chair of the Private Bills House committee; from Mr. Warren Michelson, a resignation as Chair of the Standing Committee on Intergovernmental Affairs and Justice; from Mr. Delbert Kirsch, a resignation as Chair of the Standing Committee on Human Services; as well, Mr. Greg Brkich, a resignation as Chair of the Standing Committee on Crown and Central Agencies; and from Mr. Don Toth, a resignation as Chair of the Standing Committee on the Economy.

I wish to advise that pursuant to rule 139(1) the government caucus has designated Mr. Fred Bradshaw, the Hon. Ken Cheveldayoff, Mr. Corey Tochor to replace the Hon. Jeremy Harrison, Mr. Gene Makowsky, and the Hon. Gord Wyant as members of the Standing Committee on House Services.

Okay, since we're changing the membership of the House Services, I would ask a member to move the following motion:
