STANDING COMMITTEE ON HOUSE SERVICES September 6, 2017

[The committee met at 11:00.]

The Chair: — Well good morning, everybody. Today this is the Standing Committee on House Services, September 6, 2017. I'd like to welcome everyone here today, and we are here mostly for the consideration for changes of memberships of our standing committees. Today we have Warren McCall with us; Muhammad Fiaz, Kevin Phillips, Greg Lawrence, and Greg Brkich.

First I would like to announce that pursuant to rule 139(1)(b), the government caucus has designated Hon. Greg Brkich to replace Jeremy Harrison as a member of the Standing Committee on House Services.

We will now consider changes to the membership on standing committees, pursuant to rule 139(4)(a). We will not be requiring seconders on these motions. And first up I believe is a government motion. Kevin Phillips.

Mr. Phillips: — I would move:

That the names of Scott Moe, Ken Cheveldayoff, and Herb Cox be substituted for the names of Terry Dennis, Warren Kaeding, and Kevin Phillips on the Standing Committee of Crown and Central Agencies.

The Chair: — We'll take that motion as read. Is that agreed?

Some Hon. Members: — Agreed.

The Chair: — Carried. Next motion, I'll look for a government motion on the Economy. Kevin Phillips.

Mr. Phillips: — I would move:

That the names of David Buckingham, Hon. Greg Brkich, Terry Dennis, and Greg Lawrence be substituted for the names of Hon. Steven Bonk, Lori Carr, Hon. Gene Makowsky, and Laura Ross on the Standing Committee on the Economy;

and further, that the name of Warren Kaeding be added to the Standing Committee on the Economy.

The Chair: — Kevin Phillips has made the motion. We'll take it as read. Is that agreed?

Some Hon. Members: — Agreed.

The Chair: — Carried. Yes, Mr. McCall.

Mr. McCall: — While we're at it with the Standing Committee on the Economy, Mr. Speaker, I'd like to move a motion:

That the name of Trent Wotherspoon be substituted for the name of Buckley Belanger on the Standing Committee on the Economy.

The Chair: — I believe we can do that right now. Mr. McCall has made a motion. We'll take it as read. All those agreed?

Some Hon. Members: — Agreed.

The Chair: — Carried. Next we'll have a motion on Human Services. I recognize Kevin Phillips.

Mr. Phillips: — I would move:

That name of Tina Beaudry-Mellor be substituted for the name of David Buckingham on the Standing Committee on Human Services.

The Chair: — Kevin Phillips has made a motion on changes to the Human Services Committee. We'll take the motion as read. Is that agreed?

Some Hon. Members: — Agreed.

The Chair: — Carried. Next we'll be entertaining a motion on Intergovernmental Affairs. I recognize Muhammad Fiaz.

Mr. Fiaz: — So I will move:

That the names of Laura Ross, Gordon Wyant, and Jeremy Harrison be substituted for the name of Hon. Greg Brkich, Hon. Nancy Heppner, and Lisa Lambert on the Standing Committee on Intergovernmental Affairs and Justice.

The Chair: — Muhammad Fiaz has moved a motion on Intergovernmental Affairs changes. We'll take the motion as read. Is that agreed?

Some Hon. Members: — Agreed.

The Chair: — Carried. I recognize Muhammad Fiaz.

Mr. Fiaz: — I would move:

That the names of Lisa Lambert, Randy Weekes, and Lori Carr be substituted for the names of Herb Cox, Hon. Larry Doke, and Hon. Paul Merriman on the Standing Committee on Public Accounts;

And further, that the name of Kevin Phillips be added to the Standing Committee on Public Accounts.

The Chair: — Muhammad has made a motion on changes to the structure of the Public Accounts Committee. I will take the motion as read. Is that agreed?

Some Hon. Members: — Agreed.

The Chair: — Carried. I recognize Mr. McCall.

Mr. McCall: — Thank you very much, Mr. Speaker. I'd move:

That the name of Carla Beck be substituted for the name of Nicole Sarauer on the Standing Committee on Public Accounts.

The Chair: — Mr. McCall has moved a motion to change the structure of the Public Accounts Committee for opposition members. We'll take the motion as read. Is that agreed?

Some Hon. Members: — Agreed.

The Chair: — Carried. Recognize Muhammad Fiaz.

Mr. Fiaz: — Thank you, Mr. Speaker. Then I move:

The name of Hon. Greg Brkich be substituted for the name of Hon. Paul Merriman on the Standing Committee on Private Bills.

The Chair: — Mr. Fiaz has moved a motion to change the structure of the committees. We'll take the motion as read. Is that agreed?

Some Hon. Members: — Agreed.

The Chair: — Carried. Committee members, before you is a draft of the committee's seventh report. I would ask a member to move the following motion:

That the seventh report of the Standing Committee on House Services be adopted and filed with the Clerk, pursuant to rule 136(6).

Hon. Mr. Brkich: — Mr. Speaker, I so move:

That the seventh report of the Standing Committee on House Services be adopted and filed with the Clerk, pursuant to rule 136(6).

The Chair: — All those in favour?

The Chair: — Opposed? Carried. At this time I would ask a member to move a motion of adjournment.

An Hon. Member: — So moved, Mr. Chair.

The Chair: — So moved. The Standing Committee on House Services is adjourned to the call of the Chair. Thank you, everybody.
