## STANDING COMMITTEE ON HOUSE SERVICES March 19, 2018

[The committee met at 09:33.]

The Chair: — Well hello, everyone, and welcome to the Standing Committee on House Services. Today is March 19th, 2018, 9:30 a.m. So today's agenda, we'll be considering membership changes to the standing committees. And the members in attendance today are Mr. Greg Lawrence, Ms. Lori Carr, Mr. Harrison. Mr. Bradshaw is sitting in for Mr. Brkich. Mr. McCall is sitting in for Mr. Forbes and, well, Ms. Sarauer soon. Excellent.

So consideration of changes to the membership pursuant to rule 139(4)(a). We'll now begin considering changes to membership on standing committees, beginning with the Standing Committee on House Services. I recognize Mr. McCall.

**Mr. McCall**: — Thank you very much, Mr. Chair. I would move the following motion:
