The Chair: — Okay, hello everyone. Welcome to the House Services Committee meeting for June 15th, 2020. It's 9:03 a.m. and I would like to welcome the members here. We have in attendance Ms. Beck, Hon. Mr. Harrison, Mr. Hindley, Ms. Lambert, Hon. Mr. Merriman, and Ms. Sproule.

And I want to thank the opposition as well, and Ms. Sproule particularly, for the work that we've been able to put into this and come to an agreement that I think is going to be a very positive thing as we go forward. So thanks.

The Chair: — Ms. Sproule.

Ms. Sproule: — Good morning, Mr. Speaker, committee members. I too would like to express sincere gratitude. These are remarkable times that we're living in and I believe that you have a remarkable staff. And, Mr. Clerk, as well your staff has been absolutely phenomenal in pulling this together on fairly short notice, although I know you've been working hard from the day we adjourned to figure out how this might look.

This is extraordinary times and I think it will be strange, the next three weeks, but I think we'll make it work. I too want to thank the Government House Leader. I believe we've arrived at a very reasonable process for this session, and completion date is coming soon. So thanks again to everyone and yourself, Mr. Speaker, as well for making it happen.

The Chair: — Thank you for those opening comments, both House leaders. I would also like to reiterate my appreciation. I'll have more to say a little later today, but again thanks so much for all the work that got us to this point. And it's day one. There'll be no hiccups. None, none. It'll be just seamless . . . [inaudible interjection] . . . Oh that's right. It's on the record, isn't it?

All right. So seeing no questions, I'd ask a member to move the following motion:

That the 15th report of the Standing Committee on House Services be adopted and presented to the Assembly.

Hon. Mr. Harrison: — I so move, Mr. Speaker.
