Mr. Park: — Well welcome back to everybody. We are going to move on to our Human Services Committee. So this is the first committee meeting since the resignation of the committee Chair. Mr. Steinley: — I move:

Mr. Park: — All in favour of that motion?

Some Hon. Members: — Agreed.

Mr. Park: — All opposed? All right, I declare the motion carried and invite Mr. Lawrence to take the Chair. Unfortunately Mr. Lawrence is not here today, so we will have an election of an acting committee Chair. It is the same process. So we will call for nominations for the position of acting committee Chair. Mr. Steinley.

Mr. Steinley: — I move:

That Fred Bradshaw be elected to preside as Acting Chair of the Standing Committee on Human Services for the meeting of June 13th, 2014.

Mr. Park: — Mr. Steinley has nominated Mr. Bradshaw to the position of Acting Chair. Are there any further nominations? Seeing none, I would now invite one of the members to move that motion. Mr. Steinley.

Mr. Steinley: — I move:

That Fred Bradshaw be elected to preside as Chair of the Standing Committee on Human Services for June 13th, 2014.

Mr. Park: — All in favour of that motion? All opposed? I declare the motion carried and invite Mr. Bradshaw to take the Chair.

The Acting Chair (Mr. Bradshaw): — Good morning,

members, and thank you for being here. We have with us today Mr. Ottenbreit, Mr. Steinley, Mr. Parent, Mr. Cheveldayoff and Mr. Makowsky and Mr. McCall.

Darryl Hickie authorizes Warren Steinley to attend the meeting of the Standing Committee on Human Services. David Forbes authorizes Warren McCall to attend the meeting of the Standing Committee on Human Services.

Seeing no further business, I would ask a member to move the motion of adjournment. Mr. Steinley has moved. All agreed? That is carried. The meeting stands adjourned to the call of the Chair.
