## STANDING COMMITTEE ON INTERGOVERNMENTAL AFFAIRS AND JUSTICE June 13, 2014

[The committee met at 09:35.]

**Mr. Park**: — Welcome back. We are now starting the meeting for the Standing Committee on Intergovernmental Affairs and Justice. Since this is the first meeting since the resignation of the committee Chair, we'll go through the election of a Chair.

Just to remind people of the process, we'll ask for nominations. After nominations we'll vote on the motion. I will now call for nominations for the position of committee Chair. Mr. Steinley.

#### Mr. Steinley: — I move:

That Laura Ross be elected to preside as Chair of the Standing Committee on Intergovernmental Affairs and Justice.

**Mr. Park**: — Mr. Steinley has nominated Ms. Ross to the position of Chair. Are there any further nominations? Seeing none, I would now invite the member to move that motion. Mr. Steinley.

Mr. Steinley: — I move:

That Laura Ross be elected to preside as Chair of the Standing Committee on Intergovernmental Affairs and Justice.

Mr. Park: — All in favour of the motion?

### Some Hon. Members: — Agreed.

**Mr. Park**: — All opposed? I declare the motion carried and invite Ms. Ross to take the Chair. Unfortunately Ms. Ross is not able to be with us today, so we will be electing an Acting Chair for this meeting. As the Committee Clerk, I'll preside over the election of the Acting Chair as well. I will now ask for nominations for the position of acting committee Chair. Mr. Steinley.

Mr. Steinley: — I move:

That Fred Bradshaw be elected to preside as Acting Chair of the Standing Committee on Intergovernmental Affairs and Justice for the meeting of June 13th, 2014.

**Mr. Park**: — Mr. Steinley has nominated Mr. Bradshaw to the position of acting committee Chair. Are there any further nominations? Seeing none, I would now invite the member to move that motion. Mr. Steinley.

Mr. Steinley: — I move:

That Fred Bradshaw be elected to preside as Acting Chair of the Standing Committee on Intergovernmental Affairs and Justice on June 13th, 2014.

And member Yogi Huyghebaert — excuse me, D.F. Huyghebaert — authorizes Ken Cheveldayoff to attend the meeting of the Standing Committee on Intergovernmental Affairs and Infrastructure. Mr. Paul Merriman authorizes Greg Ottenbreit to attend the meeting on the Standing Committee on Intergovernmental Affairs and Justice. Laura Ross authorizes Fred Bradshaw to attend the meeting of the Standing Committee on Intergovernmental Affairs and Justice. Doyle Vermette authorizes Warren McCall to attend the meeting of the Standing Committee on Intergovernmental Affairs and Justice.

I would like to now table documents for Intergovernmental Affairs and Justice: 23/27 — Ministry of Justice and Attorney General response to a question raised at the April 29th, 1914 meeting of the committee re outside lawyers, dated May 13, 1914, distributed to committee members on May 15, 2014 ...
