STANDING COMMITTEE ON INTERGOVERNMENTAL AFFAIRS AND JUSTICE March 19, 2018

[The committee met at 10:05.]

Mr. Park: — All right. Good morning and welcome to the Intergovernmental Affairs Standing Committee. My name is Robert Park and I am the Committee Clerk.

The committee has received a letter of resignation from Ms. Ross. Since she has resigned as Chair, it is my duty as Committee Clerk to preside over the election of a Chair. Okay, let's go over this all over again. I'm asking for a motion:

That Buckley Belanger be elected to preside as Deputy Chair of the Standing Committee on Intergovernmental Affairs.
