Add the following Clause after Clause 5 of the printed Bill:

New section 17 6 Section 17 is repealed and the following substituted:

"Alternate juror

- 17(1) If the judge presiding at the trial considers it advisable in the interests of justice to have an alternate juror, the judge shall so order before the registrar begins to empanel the jury pursuant to Part IV.
- (2) If the judge presiding at the trial considers it advisable in the interests of justice, before the registrar begins to empanel the jury pursuant to Part IV the judge may order that 7 jurors instead of 6 be sworn in accordance with that Part.
- (3) An alternate juror shall:
 - (a) attend at the commencement of the presentation of the evidence on the merits; and
 - (b) replace any absent juror if there is not a full jury present.
- (4) An alternate juror who is not required as a substitute juror shall be excused.
- (5) If one juror dies or, in the opinion of the judge presiding at the trial, becomes unable to continue to serve as a juror for any reason, the judge may direct that:
 - (a) the trial shall proceed without that juror; or
 - (b) the alternate juror, if any, shall replace that juror.

- 17(1) S'il estime indiqué, dans l'intérêt de la justice, qu'il y ait un juré suppléant, le juge présidant le procès l'ordonne avant que le registraire procède à la constitution du jury en vertu de la partie IV.
- (2) S'il estime indiqué, dans l'intérêt de la justice, que 7 jurés plutôt que 6 soient assermentés sous le régime de la partie IV, le juge présidant le procès peut l'ordonner avant que le registraire procède à la constitution du jury en vertu de cette partie.
- (3) Le juré suppléant:
 - a) doit se présenter au moment où débute la présentation de la preuve sur le fond;
 - b) remplace un juré absent, si le jury présent est incomplet.
- (4) S'il n'a pas à remplacer un juré, le juré suppléant est libéré.
- (5) En cas de décès d'un juré ou si, de l'avis du juge présidant le procès, un juré devient incapable de continuer à remplir les fonctions de juré pour quelque raison que ce soit, le juge peut ordonner:
 - a) soit que le procès se poursuive sans ce juré;
 - b) soit que le juré suppléant, s'il en est, le remplace.

(6) If a trial proceeds in accordance with clause (5)(a) without an alternate juror, a verdict may be given by the remaining jurors if they are unanimous".

(6) Lorsqu'un procès se poursuit conformément à l'alinéa (5)a) sans suppléance, un verdict peut être rendu par les autres jurés, s'ils sont unanimes ».
