QUESTIONS AND ANSWERS

Ms. Sproule asked the government the following Question No. 956, which was answered by the Hon. Mr. Boyd:

To the Minister Responsible for Saskatchewan Power Corporation: What is the definition of what is referred to by SaskPower officials as “hot sockets”?

Answer:

A hot socket is defined as the condition occurring when a meter socket jaw is defective, damaged, or has begun to lose tension, creating insufficient tension between the meter socket jaw and the blade on the rear of the meter. This condition can result in small gaps between the meter socket jaw and the meter, resulting in electrical arcing, creation of excessive heat, and possible failure of the connection between the meter socket jaw and the meter.

Ms. Sproule asked the government the following Question No. 957, which was answered by the Hon. Mr. Boyd:

To the Minister Responsible for Saskatchewan Power Corporation: What is the definition of what is referred to by SaskPower officials as “overheating”?

Answer:

Overheating is defined as the resulting condition that occurs when the temperature rating of an electrical meter, or material(s) within that device, has been exceeded.

Ms. Sproule asked the government the following Question No. 958, which was answered by the Hon. Mr. Boyd:

To the Minister Responsible for Saskatchewan Power Corporation: How many replacement meters experienced “hot socket” issues?

Answer:

Four.

Ms. Sproule asked the government the following Question No. 959, which was answered by the Hon. Mr. Boyd:

To the Minister Responsible for Saskatchewan Power Corporation: How many replacement meters experienced “overheating” issues?

Answer:

None.

Ms. Sproule asked the government the following Question No. 960, which was answered by the Hon. Mr. Boyd:

To the Minister Responsible for Saskatchewan Power Corporation: Of the 10 smart meters that failed, how many had “hot sockets” as a contributing factor?

Answer:

None. Initially, it was thought that one of the failures was attributable to hot sockets. However, after further investigation, it was concluded moisture and dust contamination combined to cause the electrical arcing.

Ms. Sproule asked the government the following Question No. 961, which was answered by the Hon. Mr. Boyd:

To the Minister Responsible for Saskatchewan Power Corporation: Of the 10 smart meters that failed, how many had “hot sockets” as a main cause?

Answer:

None.

Ms. Sproule asked the government the following Question No. 962, which was answered by the Hon. Mr. Boyd:

To the Minister Responsible for Saskatchewan Power Corporation: Of the 10 smart meters failures, how many of these failures were a result of or were contributed to by issues extended to the meter specifically?

Answer:

10

Ms. Sproule asked the government the following Question No. 963, which was answered by the Hon. Mr. Boyd:

To the Minister Responsible for Saskatchewan Power Corporation: What were all the specific contributing factors, internal or external, to the 10 smart meter failures?

Answer:

Moisture and dust contamination combined to cause electrical arcing inside all 10 of them.

Ms. Sproule asked the government the following Question No. 964, which was answered by the Hon. Mr. Boyd:

To the Minister Responsible for Saskatchewan Power Corporation: How many of the 10 smart meter failures were caused exclusively be internal issues within the meter (i.e. moisture and dirt)?
