PASSING OF HER MAJESTY QUEEN ELIZABETH II

Moved by the Hon. Mr. Moe, by leave of the Assembly:

That an Humble Address be presented to His Majesty the King in the following words:

TO THE KING'S MOST EXCELLENT MAJESTY:

We the members of the Legislative Assembly of Saskatchewan in session assembled, respectfully tender our deep sympathy for the loss you have suffered by the death of Your Majesty's mother, our late beloved sovereign.

Your Majesty's sorrow is shared by the people of Saskatchewan, with a deep sense of loss arising from their recollections of a dignified and graceful Monarch of Canada and the Commonwealth.

Many in our province have fond memories of Her Late Majesty Queen Elizabeth II as she visited our province first as Princess Elizabeth in 1951 and then on five occasions as Queen in 1959, 1973, 1978, 1987 and 2005.

We humbly pray that the knowledge of Her Late Majesty's long life of selfless devotion to duty, integrity, and wisdom, which left a deep and lasting impact on so many people in Saskatchewan and around the world, will sustain comfort to you and your family.
