Petitions of citizens of the province of Saskatchewan were presented and laid upon the Table by the following members: Noor Burki, Jared Clarke, David Chan, Hugh Gordon, and Tajinder Grewal.

READING AND RECEIVING PETITIONS

According to order and pursuant to rule 16(7), petitions from residents of the province of Saskatchewan, requesting the following action, were read and received:

To immediately mandate education on intimate partner violence be included in the orientation process for all new employees across all workplaces in the province.

To immediately address the short-staffing crisis in health care.

To enshrine Duty to Consult into law by enacting meaningful duty to consult legislation.

To call upon the Government of Canada to take immediate action to remove the harmful tariffs on canola, pork, and peas that are disproportionately affecting the producers and farmers of the province of Saskatchewan.
