



**Ms. Lang:** — Good morning committee members. Good morning to the committee members and those substituting for the Crown and Central Agencies Committee.

As Committee Clerk, you may be aware that the resignation of Mr. Dustin Duncan as Chair of this committee, as well as the Deputy Chair positions have been . . . both have resigned their positions. So it's my duty as Committee Clerk to preside over the election of a new Chair, and I now call for nominations for that position. Mr. Gantefoer.

**Hon. Mr. Gantefoer:** — Thank you, Madam Clerk. I move:

That Tim McMillan be elected to preside as Chair of the Standing Committee on Crown and Central Agencies.

**Ms. Lang:** — Any further nominations? Seeing none, Mr. Gantefoer has moved:

That Tim McMillan be elected to preside as Chair of the Standing Committee on Crown and Central Agencies.

Is that agreed?

**Some Hon. Members:** — Agreed.

**Ms. Lang:** — Carried. Normally in this situation, the new Chair of the committee would preside over the election of the Deputy Chair. However we do not have the current Chair in attendance today, therefore you'll need to elect an Acting Chair for today's meeting.

Any nominations for Acting Chair? Mr. Gantefoer.

**Hon. Mr. Gantefoer:** — Thank you. I move:

That Delbert Kirsch be elected to preside as Acting Chair of the Standing Committee on Crown and Central Agencies for the meeting of June 15, 2009.

**Ms. Lang:** — Is the committee ready for the question?

**Some Hon. Members:** — Question.

**Ms. Lang:** — Mr. Gantefoer has moved:

That Delbert Kirsch be elected to preside as Acting Chair of the Standing Committee on Crown and Central Agencies for the meeting of June 15, 2009.

Is that agreed?

**Some Hon. Members:** — Agreed.

**Ms. Lang:** — Carried. I invite Mr. Kirsch to take the Chair.

**The Acting Chair (Mr. Kirsch):** — We would ask for nominations for Deputy Chair. Mr. Yates.

**Mr. Yates:** — Mr. Chair, I move:

That Buckley Belanger be elected to preside as Deputy Chair of the Standing Committee on Crown and Central Agencies.

**The Acting Chair (Mr. Kirsch):** — We have a motion for Buckley Belanger nominated Deputy Chair of the Standing Committee of Crown and Central Agencies. Is that agreed?

**Some Hon. Members:** — Agreed.

**The Acting Chair (Mr. Kirsch):** — Carried.

Okay, there are four documents to be tabled with the committee: CCA 132/26, Information Services Corporation of Saskatchewan. The next one is Saskatchewan Telecommunications Holding Corporation, and the next one is Public Service Commission. And the last one is Ministry of Government Services.

We would now entertain a motion for adjournment. Mr. Yates. The committee agreed?

**Some Hon. Members:** — Agreed.

**The Acting Chair (Mr. Kirsch):** — Carried. The committee now stands adjourned.
