Bill 15 – Committee Follow-Up

Saskatchewan Liquor and Gaming Authority

On May 6, 2025, I, along with SLGA officials, appeared at committee to answer questions about Bill 15 – An Act to amend The Alcohol and Gaming Regulation Act, 1997. Additional information was requested of a high-level breakdown of suspensions. fines, and cancellations by permit type (restaurant, tavern, retail (RSP) and craft producer) for the years 2023, 2024, and 2025 is below.

The Alcohol and Gaming Regulation Act, 1997 requires that the Saskatchewan Liquor and Gaming Authority (SLGA) provide permittees with the option to serve a suspension in lieu of payment of the monetary fine. When a permittee opts to serve a suspension, SLGA sets the dates for the suspension. The summary reflects the times when a permittee chose to serve a suspension.

I note, and offer apologies, that the initial numbers provided during committee were not accurate due to errors made in interpreting the internal reporting. The numbers provided to the committee were as follows:

- 2023 eight suspensions, and 30 fines imposed
- 2024 13 suspensions and 65 fines, along with one cancellation.
- 2025 one suspension and 21 fines issued

## The revised summary is:

- 2023 18 suspensions and 64 fines imposed, total 82 0
- 2024 18 suspensions and 67 fines imposed, total 85 0
- 2025 (to March 31, 2025) 4 suspensions and 35 fines imposed, total 39 0

These are based on the calendar year.
