(Mr. Belanger)

Q. So when you indicate the percentages of product, which of Saskatchewan's export, what percentage goes to Alberta and BC? Would you break those down for me?

Answer:

Please find attached a table that illustrates the percentages of energy exports from Saskatchewan to other provinces and internationally from Statistics Canada. In addition to the data from Statistics Canada, the Petrinex system, which provides energy data from oil and gas producers to the Governments of Saskatchewan and Alberta for royalty/tax purposes, indicated that there were incidental rail shipments of Saskatchewan crude oil in 2014 to British Columbia, roughly 2.3 million barrels worth about \$190 million, much less after rail charges.
