**The Chair:** — Okay, hello everyone. Welcome to the Standing Committee on House Services. Today is September 16th, 2019. It's 9 a.m. and we're in room 8. Today we will be considering membership changes to the standing committees.

And as we start, committee members, as you're aware, over the last three years the broadcast system for both this room and the Chamber have been upgraded. All proceedings will soon be available in high definition. For the public, today's proceedings are being live-streamed online on the Legislative Assembly website, will be archived and broadcast on the legislative channel at a later date.

I will advise you and all members when the HD [high-definition] broadcast is fully operational.

Number two. So with us today, subbing in for Lisa Lambert is Laura Ross. We've got Everett Hindley. We've got Paul Merriman. We've got Jeremy Harrison, and we've got Carla Beck. So welcome all.

I would ask for someone to move a motion to amend the House Services steering committee membership. Mr. Everett Hindley. Do we have somebody to second that? No seconder? Okay . . . [inaudible interjection] . . . what's that? Okay, got to read it, yes.

**Mr. Hindley:** —

That the steering committee established at the organizational meeting of the Standing Committee on House Services be comprised of the Speaker, Ms. Sproule, and the Hon. Mr. Harrison.

**The Chair:** — Is everyone in agreement?

**Some Hon. Members:** — Agreed.

**The Chair:** — Carried.

All right. I'm going to ask for a motion to amend the House Services rules subcommittee membership. Mr. Everett Hindley.

**Mr. Hindley:** —

That the rules revision subcommittee of the Standing Committee on House Services be comprised of the Speaker, Ms. Sproule, and the Hon. Mr. Harrison.

**The Chair:** — Carried.

Okay, I would ask for a government member to move membership change motions one at a time. Ms. Ross.

**Ms. Ross:** — I move:

That the names of Fred Bradshaw and Hugh Nerlien be substituted for the names of Herb Cox and Everett Hindley on the Standing Committee on Crown and Central Agencies.

**The Chair:** — Members agree?

**Some Hon. Members:** — Agreed.

**The Chair:** — Carried.

**Ms. Ross:** — I move:

That the name of Hugh Nerlien be substituted for the name of Dan D'Autremont on the Standing Committee on Human Services; and further,

That the name of Herb Cox be added to the Standing Committee on Human Services.

**The Chair:** — All members in agreement?

**Some Hon. Members:** — Agreed.

**The Chair:** — Carried. More?

**Ms. Ross:** — I move:

That the names of Greg Lawrence and Dan D'Autremont be substituted for the names of Fred Bradshaw and Hugh Nerlien on the Standing Committee on Intergovernmental Affairs and Justice; and further,

That the name of Randy Weekes be added to the Standing Committee on Intergovernmental Affairs and Justice.

**The Chair:** — Committee members in agreement?

**Some Hon. Members:** — Agreed.

**The Chair:** — Carried. One more.

**Ms. Ross:** — I move:

That the names of Greg Brkich, Herb Cox, and David Buckingham be substituted for the names of Lori Carr, Todd Goudy, and Warren Michelson on the Standing Committee on Public Accounts.

**The Chair:** — Committee members in agreement?

**Some Hon. Members:** — Agreed.

**The Chair:** — Carried. Yes.

**Ms. Ross:** — I move:

That the names of Fred Bradshaw, Jeremy Harrison, and Delbert Kirsch be substituted for the names of Greg Brkich and Dan D'Autremont and Randy Weekes on the Standing Committee on Private Bills; and further,

That the name of Don McMorris be added to the Standing Committee on Private Bills.

**The Chair:** — Committee members in agreement?

**Some Hon. Members:** — Agreed.

**The Chair:** — Carried.

**Ms. Ross:** — I move:

That the names of Jeremy Harrison, Everett Hindley, and Lisa Lambert be substituted for the names of Greg Brkich, Dan D'Autremont, and Greg Lawrence on the Standing Committee on Privileges.

**The Chair:** — Committee members in agreement?

**Some Hon. Members:** — Agreed.

**The Chair:** — Carried. It's the end of the motions, okay.
