The Deputy Chair: — Welcome, members. I'm Vicki Mowat, the Deputy Chair of the Standing Committee on House Services. Today with us we have Ms. Carla Beck, Mr. Greg Ottenbreit, Mr. Doug Steele, the Hon. Randy Weekes, who is the Chair. And substituting for Mr. Terry Dennis, we have Daryl Harrison. Substituting for the Hon. Jeremy Harrison, we have David Buckingham.

I'd like to inform the committee that pursuant to rule 139(5), the following estimates and supplementary estimates were committed to the Standing Committee on House Services on March 31st, 2022 and March 23rd, 2022, respectively. 2022-2023 estimates: vote 76, Advocate for Children and Youth; vote 34, Chief Electoral Officer; vote 57, Conflict of Interest Commissioner; vote 55, Information and Privacy Commissioner; vote 21, Legislative Assembly; vote 56, Ombudsman and Public Interest Disclosure Commissioner; vote 28, Provincial Auditor; and supplementary estimates no. 2, vote 34, Chief Electoral Officer.

The Deputy Chair: — Carried. Ombudsman and Public Interest Disclosure Commissioner, vote 56 — 4,213,000. I will now ask a member to move the following resolution:

Resolved that there be granted to Her Majesty for the 12 months ending March 31st, 2023, the following sums for Ombudsman and Public Interest Disclosure Commissioner in the amount of 4,213,000.

Resolved that there be granted to Her Majesty for the 12 months ending March 31st, 2023, the following sums for Provincial Auditor in the amount of 9,182,000.
