## **Ratio of Members on Standing Committees**

Three by-elections were held on August 10, 2023 which changed the proportions of party membership in the Assembly. As well, the Premier appointed a number of committee members to cabinet. These events necessitated the Standing Committee on House Services to revise the ratio of members on standing committees pursuant to rule 122(1) as well as revise the individual membership of the committees.

In regard to the ratio of members on standing committees, the committee made the following recommendation:

#### **Recommendation 1:**

That notwithstanding the provisional order for membership of the Standing Committee on Public Accounts and rule 139(1) regarding membership of the Standing Committee on House Services, the standing committees' member ratio shall be five government members and two opposition members, except for the Standing Committee on Privileges which shall be four government members and two opposition members.

# Remembrance Day Statutory Holiday Observation

In 2023, Remembrance Day falls on a Saturday. However, there is no provision in the *Rules and Procedures of the Legislative Assembly of Saskatchewan* to observe the statutory holiday on a weekday in this circumstance. As a result, the committee recommends:

#### **Recommendation 4:**

That notwithstanding rule 6(4) of the *Rules and Procedures of the Legislative Assembly of Saskatchewan*, when the Assembly adjourns on Thursday, November 9, 2023, it shall stand adjourned until Tuesday, November 14, 2023 at 1:30 p.m. and, that in accordance with rule 3(2), the 25<sup>th</sup> and final day of the fall period of the revised parliamentary calendar shall be Thursday, December 7, 2023.
