**4. Who was on the committee, the ~~child and family agenda~~ committee prior to being dismantled?...If it's all the same ministers, why was this committee dismantled and changed into the human services?**

Answer:

The membership of Human Services Cabinet Committee is not the same as the former Cabinet Committee on the Saskatchewan Child and Family Agenda (SCFA). The new committee expanded membership to include the Ministers of the Economy and Advanced Education. The Minister of Parks, Culture and Sport is no longer a member.

The aim of the SCFA was to better support the well-being of all children and youth and their families. This work has been subsumed into the broader scope of a shared agenda which is working to leverage and expand on the SCFA and support the Plan for Growth.
