RE: Submissions from the Employment Standards Review

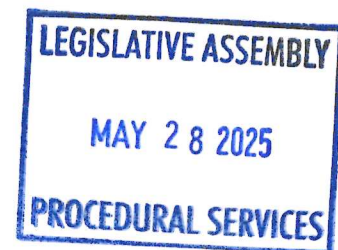
