

**Ms. Lang:** — Good morning, committee members. Welcome to the Intergovernmental Affairs and Justice Committee. I'd like to make committees aware that I've received resignations from the Chair, Mr. Kirsch, as the committee Chair of Intergovernmental Affairs and Justice Committee, as well as Ms. Higgins, the Deputy Chair.

**Hon. Mr. Gantefoer:** — Thank you, Madam Clerk. I move:

**Ms. Lang:** — Any further nominations for Acting Chair? Seeing none, it's been moved by Mr. Gantefoer:

**Some Hon. Members:** — Agreed.

**Ms. Lang:** — Carried. I invite Mr. Weekes to take the Chair.

**Mr. Yates:** — Thank you very much. Mr. Chair, I'd move:

That Kim Trew be elected to preside as Deputy Chair of the Standing Committee on Intergovernmental Affairs and Justice.

**The Acting Chair (Mr. Weekes):** — Carried.
