**Chair B. McLeod:** — Welcome to the Standing Committee on Intergovernmental Affairs and Justice. This might be the shortest meeting we've ever had. We'll see.

Thank you for everyone here tonight. And the meeting has been called because the committee has received a letter from MLA Roy resigning as Deputy Chair. And since she has resigned, our only item of business today is to elect a new Deputy Chair.

Now I will remind members of the process. I will first ask for nominations. Once there are no further nominations, I will then ask a member to move a motion to have a committee member preside as Deputy Chair.

So I will now call for nominations for the position of Deputy Chair. I recognize MLA Roy.

**Jacqueline Roy:** — Mr. Speaker, I nominate Tajinder Grewal to the position of Deputy Chair.

**Chair B. McLeod:** — MLA Roy has nominated Tajinder Grewal to the position of Deputy Chair. Are there any further nominations? Seeing none, I would now invite one of the members to move the motion. I recognize MLA Roy.

**Jacqueline Roy:** — I move that Tajinder Grewal be elected to preside as Deputy Chair of the Standing Committee on Intergovernmental Affairs and Justice.

**Chair B. McLeod:** — It has been moved by MLA Roy that MLA Tajinder Grewal be elected to preside as Deputy Chair of the Standing Committee on Intergovernmental Affairs and Justice. All in favour of the motion?

**Some Hon. Members:** — Agreed.

**Chair B. McLeod:** — All those opposed? Hearing none, I declare the motion carried.
