- A SHA employee misused a parking pass over a six-month period, resulting in a loss of \$577.00

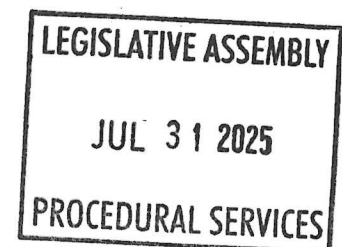
The *Losses of Public Money* report along with a news release will be published on the Government of Saskatchewan's website on August 5, 2025.

| August 2024 to February 2025 | Saskatchewan Health Authority – Saskatoon | Misuse of parking pass | \$577.00 | A SHA employee used an unpaid parking transponder from August 2024 to February 2025, resulting in \$577.00 in unpaid fees. The employee had reported the original parking pass as lost and a replacement was issued. Both passes were being used simultaneously by both the employee and other individuals. Employee received a 10-day suspension and is reimbursing the full amount owed. Improvements underway include enhanced training for parking staff and the implementation of a new parking management system. |
