# CONGRATULATIONS TO ESTEVAN HOCKEY TEAM

**Mr. J.W. Gardiner** (**Melville**): — Mr. Speaker, I would just like to join in the congratulations to the member for Estevan (Mr. MacDougall) for the win his team had the other night, and the fact that they won the Saskatchewan Junior Hockey League Championship. I think Melville this year may have to settle for a win by Sid Abel in Detroit in their undertaking of the winning of the National Hockey League after last night, and he will have to do the honors for Melville this year.

I would like to point out that it is two of the smaller centres in the province that this year have brought the honors as far as Junior Hockey is concerned which I think is a great tribute to both the centres of Melville and Estevan, that they have put up the show that they have in Junior Hockey in the province here this past season.

**Hon Mr. Williams**: — Mr. Speaker, on behalf of one of the larger centres in the province, I would like to congratulate the representatives of the two smaller centres.

At 7:50 o'clock p.m. His Honour the Lieutenant-Governor entered the Chamber, took his seat on the Throne, and gave Royal Assent to the bills presented to him.

His Honour the Lieutenant-Governor then said: Mr. Speaker, and Members of the Legislative Assembly:

It is my duty to relieve you of further attendance at the legislative assembly. In doing so I wish to thank you and congratulate you upon the results of your deliberations.

The additional funds you have appropriated will permit the expansion of programs designed to serve the farmer and to develop and diversify the agricultural resources of our province.

The provision of additional scholarships will be welcomed throughout the province. These will enable many more young people to obtain higher education.

The extent to which Saskatchewan has been able to develop its industrial potential in recent years has been the result of the combined efforts of many individuals, organizations, corporations, co-operatives and governments, both local and provincial.

The Industrial Development Act passed at this session will provide a more formal means for all sectors of the provincial economy to give further attention to our industrial growth.

The growing complexity of governments continues to make more difficult the responsibility of legislators to review the expenditures of public funds. it is earnestly hoped that your action to establish a Special Committee of the legislature to consider matters relating to the review of Public Accounts will provide even better means for the protection of the public interest.

Public and private authorities have always been vested with the right to acquire land for public purposes by expropriation proceedings if necessary. While it is essential that this right be preserved it is incumbent upon legislators to ensure that expropriation proceedings adequately meet changing conditions and continue to pay full regard to the rights of the citizen. Your action in establishing a Special Committee of the legislature to examine into matters relating to the expropriation of land by public and private authorities is commendable.

Legislation which you have passed will provide for the formal filing, publication and review of government regulations which are of a legislative nature. This innovation will provide an additional means of safeguarding the rights of citizens.

I am pleased to note that you voted funds for the Saskatchewan Diamond Jubilee and Canada Centenary Committee. Public recognition is again given to the members of this committee and their willingness to serve Saskatchewan in this capacity. All citizens are urged to assist in the work of this committee to ensure the success of celebrations on the sixtieth anniversary of the establishment of Saskatchewan and the one hundredth anniversary of Canadian Confederation.

Never has Saskatchewan been better represented in the world of sports beyond our borders than by the 1963 winners of the Dominion curling Championship and the World Curling Championship. It was most appropriate that you again extended suitable honors to these sportsmen.

I thank you for the provision you have made to meet the further requirements of the public service and assure you that the sum of money voted will be used economically, prudently and in the public interest.

In taking leave of you, I desire to thank you for the manner in which you have devoted your energies to the activities of the Session, and wish you the full blessing of Providence on your return to your respective homes.
