INTRODUCTION OF MLA FROM WINNIPEG

HON. K. THORSON (Minister of Industry and Commerce): — I want to take this opportunity, Mr. Speaker, to introduce to the Assembly Mr. Bud Boyce from Manitoba, MLA for Winnipeg Centre, seated behind the rail.

MR. THORSON: — Mr. Boyce is the Legislative Assistant to the Hon. Len Evans, Minister of Industry and Commerce in the Government of Manitoba. Mr. Boyce's visit with us today coincides with the arrival of these canned goods which are on every Member's desk, Mr. Speaker. They come from a processing plant in Morden, Manitoba, owned and operated by Morden Fine Foods Limited, which is a wholly owned subsidiary of the Manitoba Development Corporation. The manager of the operation along with Mr. Boyce are concerned to do what they can to promote the use and sale of prairie produced products and that is the reason for his visit to Saskatchewan and to Regina today. We have said many times that we are concerned about the prairie basin market. We have no producers of such canned goods in Saskatchewan. We are very

happy to see that our sister Province of Manitoba is able to process these prairie agricultural products and for prairie consumers. We hope to reciprocate by sending goods to them.

QUESTIONS

COMMUNITY CLINICS – SASKATOON, REGINA, PRINCE ALBERT

MR. G.B. GRANT (Regina Whitmore Park): — Mr. Speaker, before the Orders of the Day I should like to direct a question to the Minister of Health (Mr. Smishek). I wonder if he would tell us whether any of the Community Clinics in Saskatoon, Regina or Prince Albert and/or the physicians working in those Clinics are presently submitting medical accounts to the MCIC Commission for payment on a fee-for-service basis?

HON. W.E. SMISHEK (Minister of Public Health): — Mr. Speaker, I gather when I was absent yesterday there was some discussion in the House as to what arrangements that have been made in Prince Albert an allegation was made that I tried to misinform the House the day before. Mr. Speaker, we have reached agreement with the Community Clinics in Prince Albert, Saskatoon and Regina for a global budget of payment to the Community Clinics. I advised the House of this the day before yesterday. The Hon. Member has asked the question whether any of these physicians that are working in the Community Clinics are still submitting accounts on a fee-for-service basis. I can't answer that question directly because the global budget went into effect as of last month. Now whether any accounts have been received billing MCIC on a fee-for-service basis during this month or last month I would have to check. I would be glad to check with the Medical Care Insurance Commission and give the House the information.

MR. GRANT: — A supplementary question, I would appreciate if he would bring that information in tomorrow. When he makes his remarks tomorrow he might also comment on the legality of the global type agreement that was entered into with these three Community Clinics.

MR. SMISHEK: — I'll be glad to do it.

HON. J.E. BROCKELBANK (Minister of Public Works): — Mr. Speaker, I just want to say a word of two about the item that was placed on our desk earlier today which the Minister of Industry and Commerce (Mr. Thorson) had something to say about. As the Minister-in-Charge of the Purchasing Agency I note that the quality of the product is "Canada Fancy" and as a consequence I think I can safely say that the Purchasing Agency will be giving that product every chance to tender on orders that may come before the Purchasing Agency.

SCHOOL TEXTBOOK GRANT

- MR. C.P. MacDONALD (Milestone): Mr. Speaker, before the Orders of the Day, I should like to direct a question to the Minister of Education (Mr. MacMurchy). Tell me if the School Textbook Grant that was paid last year by separate check by the Department of Education is now being included in the global figure for school grants this year and if this is included as part of the increase in grants?
- **HON. G. MacMURCHY (Minister of Education)**: The School Textbook Grant is included in the global operation grant formula this year.
- **MR.** MacDONALD: Mr. Speaker, a supplementary question. Is he in reality saying that the \$1 million or the \$1.5 million that is included in that global figure is then in reality not an increase?
- **MR.** MacMURCHY: Mr. Speaker, I have the actual operating grants for 1971-72 and they are, according to my figures here, \$76,670 millions. That's the total operating grants to schools. The figure this year, according to what I have in front of me, will be \$90,063 millions.
- **MR.** MacDONALD: Mr. Speaker, would the Minister mind tabling for the Members of the House the breakdown of that \$90 million?
- **MR. SPEAKER**: That will come in his Estimates, or can be got in the Estimates at that time when the Estimates are before the

House. I think Members should then get the breakdown to their satisfaction at that time.
