# FIRING OF LONG-TERM EMPLOYEE OF AGENT GENERAL'S OFFICE

**MR. J.G. LANE** (Lumsden): — Before the Orders of the Day I should like to direct a question probably to the Minister of Industry (Mr. Thorson).

The Government of Saskatchewan I understand recently fired a long-term employee out of the Agent General's Office in England and the allegation was made that there was inadequate or unfair compensation pay.

The only reason that the matter was not reviewed in England is because supposedly the office of the Agent General had diplomatic immunity.

Is it the practice of the Government opposite to, (1) fire such employees of such long-term as over 20 years and, (2) to give such inadequate compensation and will the Government review their position?

**MR. THORSON**: — Mr. Speaker, the answer is No.

**MR. LANE**: — No, you will not give adequate compensation. Well I think that is a pretty sorry blot on the records. I think it has brought us in a bad light in England. It has been a black mark against the province and I would hope the Government would reconsider its position.

**MR. THORSON**: — The question was, is it the policy to pay inadequate compensation on severance of employment and the answer is No.

## LONG DISTANCE CALLS

**MR. K.R. MacLEOD** (Regina Albert Park): — Mr. Speaker, before the Orders of the Day I should just like to ask a question of the Minister of Telephones.

I see this matter has received some other attention but last week I tried for about 15 minutes to get a long distance call through to Ottawa, that was last Monday. This morning I just about wore my finger out trying to get a call through and I wonder if . . .

**SOME HON. MEMBERS**: — Hear, hear!

**MR. MacLEOD**: — Quite frankly I wore my finger out without getting through to Ottawa and I wondered if the Minister could tell us what steps are being taken, if any, to rectify the situation with our telephone system. Now I know that this matter seems hilarious to the Government but I know that surely they are not deliberately trying to stifle the Opposition in this matter.

**HON. J.E. BROCKELBANK** (Minister of Government Services): — Sask Tel provides an impartial service, Mr. Speaker. The first step that we take in order to attempt to alleviate problems that might occur to customers is to ask the customer to check with the Trouble Department. There is a number that you phone and they will respond and deal with your problem. If the Member finds that is inadequate I would certainly be pleased to hear about it.

**MR. MacLEOD**: — I would just simply assure him that I have done so and I want to say to the Minister that his staff at the Telephones is doing an excellent job because they have started to put me through by the long distance operator, because obviously the direct distance dialing isn't working.
