There are 17 or 18 pages of these questions which could have very easily, by any member with half a brain — in fact, he wouldn't have needed that much — been put into one question and saved us at least two or three hours of this House's time. However, I think if the member Saskatchewan wish to ask their question sin this form, we certainly will comply with it as we have no other choice. My guess is, if I can take a look at these questions — that by the time we total up the cost of answering all the questions on the order paper, it will be several hundred thousand dollars may approach \$1 million.

We could say to this motion, unamended agreed, and give a nil answer because the question is directed to contracts of consulting, etc. with the potash corporation. So far as I know, Mr. Speaker, we don't, the people of Saskatchewan, have such a thing as the potash corporation. I don't know what potash corporation is referred to here, if any; but I have a hunch what the member means is the Potash Corporation of Saskatchewan, PCS. In the spirit of openness, notwithstanding what is really behind this, I'm going to tender this amendment, seconded by my colleague, the Provincial Secretary (Mr. Cowley) that all the words after 'showing' be deleted and the following substituted therefor:

(1) The number of consultants or consulting firms who have been awarded contracts by the Potash Corporation of Saskatchewan. . .

May I add here parenthetically, it would be a good idea if your question writers would check with us first and we will help to clear up the questions here.

MR. ROMANOW: — Mr. Speaker, again, this is another small or large example. We're going to answer the question; there has to be an amendment in order to make it somewhat manageable. But this is an example of the thing we've been trying to say all day today. The question is the departments, Crown corporations, boards, commissions, etc. issuing charge cards to employees on job related transportation, cars,

rental, etc. And down it goes in general guidelines and the like.

Now, the two points I'd like to make here, Mr. Speaker, are the obvious ones, and they are that this job alone, if adopted, would be virtually impossible to comply with — virtually impossible! . . . (inaudible interjection) . . . Yes, yes. I don't know how many cars there are in the government employ — we'll find that out during estimates. But each one of them has — how many credit cards?

AN HON. MEMBER: — Twenty or thirty.

MR. ROMANOW: — Twenty or thirty credit cards. Out of ... [inaudible interjection] ... Oh no. Shame. Interesting to hear that — that you would deny our civil servants, when they're travelling around the province of Saskatchewan, the access to that kind of an operation, according to your point of view ... [inaudible interjection] ... Just one. And if it were yours it would be Shell, not a co-op one. Would it be the co-op one? You table it. The hon. member says he has only one. Well, Mr. Speaker, it's unbelievable it happened to be the hon. member for Indian Head-Wolseley who carries one around. The Shell credit card is the one he carries around I suppose. He wouldn't carry a co-op credit card. He wouldn't carry a Petro-Can credit card. That's for sure, because those guys wanted to do away with Petro-Can. I don't want to make a speech but I could be very, very tempted to make one.

Mr. Speaker, this is a very complicated question. What we're going to do is make a small amendment which deletes part (c) of 6 of the question — the names of the individuals whose cards were withdrawn, the reasons they were withdrawn and the number of cards ordered withdrawn. The way this question is worded it would mean virtually anybody who quits has a credit card withdrawn from him or, when there is a switch in employment. Furthermore, this may or may not imply some form of a search of breaking of credit card guidelines. I don't know if it does or not — virtually impossible.

Mr. Speaker, I think what I have to propose here is a reasonable compromise for the information, although I must tell the House again, and I want to tell all members, this will take a tremendous amount of work to dig up the information. The proposed amendment will be that all the words after subparagraph 2 be deleted and the following substituted therefor:

- (2) the number of cards currently authorized;
- (3) the names of the companies that have issued credit cards to these entities;
- (4) the general guidelines or regulations that govern issuants and use of such cards;
- (5) the total amount paid to the issuing firms on such cards from March 1, 1979 to March 25, 1980;

(6) the highest amount charged to a credit card from March 1, 1979 to March 25, 1980, and the holder of that card.

Now, I repeat, Mr. Speaker, when the totality of this uncovered, well I don't want to say we'll have to have a wheelbarrow to bring in the information because that may be a slight exaggeration but, there will be a lot of this. May I say, Mr. Speaker, the practice

here is one which has been established by the government now over many years — certainly before the beginning of this administration, and I don't know, I suppose since the early '60s. So it is an accepted practice used in governments, not only in Saskatchewan but outside. It's going to be a massive job, but we'll do it. It embraces the spectrum and that's what we'll do, but I simply want to pinpoint that its going to be a toughie

MR. COWLEY: — A couple of comments here. I notice the member shaking his head when the Hon. Attorney General mentioned 20 or 30 credit cards, but in all government vehicles there are government credit cards. They aren't plastic credit cards like Shell or whatever, but they could be used at any service station. You and the service station operator sign them. They are each individually a credit card and so taken literally, the way the question was asked, each and every one of those (each of which has a separate number) is a separate credit card issued not really to the individual because they are issued to the government vehicle. These are the kinds of problems you get into when you start dealing with this kind of a question, with respect to credit cards. So it wasn't 20 or 30 plastic cards, the kind we think of but there are separate, individually numbered credit cards.

The other comment I'd make is with respect to credit cards; anything charged on a government credit card has to be submitted by the employee in exactly the same way as though he had paid cash for it and got a receipt. There is every bit as much control on a credit as there is on the employees' expenditures for which he claims reimbursement. And so, whether or not there is a credit card one could argue is irrelevent in terms of what the employee is doing, because the same mode of control is used for his own expenditures through cash as is used for the employees' expenditures through a credit card. Thank you, Mr. Speaker.

MR. SPEAKER: — Will the member take a question?

MR. COWLEY: — I'll take a question.

MR. KATZMAN (**Rosthern**): — Are you suggesting that the only credit card the government has is the booklet where you rip each one out, and that you have none of the plastic ones for some different company?

MR. COWLEY: — I wasn't suggesting that at all. I was talking about one kind of credit card. If we are going to answer for all the credit cards in government, each and every one of those would have to be listed as a separate credit card because that's what they are legally. Each is a separate credit card. I'm not saying there aren't other credit cards.

Yes, I believe it's item 150, Return No. 177. So it looks like it's a double question. Now, Mr. Speaker, in the spirit of openness of this government, which we have exhibited all night and all afternoon, I am recommending to the members of the House we pass this resolution. We'll do our best to provide the answer just as we have agreed to do with respect to item 177. Well, actually, I don't think we can pass it. I beg leave to adjourn the debate, Mr. Speaker.

(1) Whether, since March 1, 1979, any consultants or consulting firms have been awarded a contract with the Prairie Agricultural Machinery Institute. (a) If so, the nature of the contract or contracts, the name and address of each consultant or consulting firm, the value of the contract, and the purpose of the contract. (b) In each instance, whether the contract was advertised or awarded without advertising.

MR. ROMANOW: — Mr. Speaker, I am going to ask the members of the House to defeat this motion. This requests information respecting the Prairie Agricultural Machinery Institute, which the hon. members should know is a tripartite corporate company set up by consultation and agreement for the provinces of Manitoba, Saskatchewan, and Alberta. As such, we only have one-third say over it, and accordingly, there's no way we can deliver on this. I am asking the members to defeat.

Motion is negatived.

Return No. 230

MR. E.A. BERNTSON (Leader of the Opposition) moved, seconded by the member for Estevan (Mr. Larter) that an order of the Assembly do issue for Return No. 230 showing:

MR. E.A. BERNTSON (Leader of the Opposition) moved, seconded by the member for Estevan (Mr. Larter) that an order of the Assembly do issue for Return No. 231 showing:

(1) Whether, since March 1, 1979, any consultants or consulting firms have been awarded a contract with the Department of Revenue, Supply and Services. (a) If so, the nature of the contract or contracts, the name and address of each consultant or consulting firm, the value of the contract, and the purpose of the contract. (b) In each instance, whether the contract was advertised or awarded without advertising.

MR. ROMANOW: — Mr. Speaker, I move, seconded by the Provincial Secretary (Mr. Cowley), that all the words after the word 'showing' be deleted and the following substituted therefor:

(a) If so, the nature of the contract or contracts, the name and address of each consultant or consulting firm, the value of the contract, and the purpose of the contract. (b) In each instance, whether the contract was advertised or awarded without advertising.

MR. ROMANOW: — Mr. Speaker, I move, seconded by the Provincial Secretary (Mr. Cowley), that all the words after the word 'showing' be deleted and the following substituted therefor:

(1) The names of all reports and studies commissioned by the public employees' superannuation plan to external consultants during the period March 1, 1979 to March 25, 1980; and (2) the names of these consultants and the final cost.

Amendment agreed.

Motion as amended agreed.

Return No. 233

MR. E.A. BERNTSON (Leader of the Opposition) moved, seconded by the member for Estevan (Mr. Larter) that an order of the Assembly do issue for Return No. 233 showing:

(1) Whether, since March 1, 1979, any consultants or consulting firms have been awarded a contract with the teachers' superannuation commission. (a) If so, the nature of the contract or contracts, the name and address of each consultant or consulting firm, the value of the contract, and the purpose of the contract. (b) In each instance, whether the contract was advertised or awarded without advertising.

MR. ROMANOW: — Mr. Speaker, I move, seconded by the Provincial Secretary (Mr. Cowley), that all the words after the word 'showing' be deleted and the following substituted therefor:

(1) The names of all reports and studies commissioned by the teachers'

superannuation commission to external consultants during the period March 1, 1979 to March 25, 1980; and (2) the names of these consultants and the final costs.

Amendment agreed.

Motion as amended agreed to.

Return No. 501

MR. G.S. MUIRHEAD (**Arm River**) moved, seconded by the member for Wilkie (Mr.Garner) that an order of the Assembly do issue for Return No. 502 showing:

A detailed outline from the Department of the Environment on how the Government of Saskatchewan plans to dispose of all wastes resulting from uranium mining and refining in Saskatchewan.

MR. ROMANOW: — Mr. Speaker, the hon. member for Estevan asks, how can I amend this one? I must confess that it is not easy especially when you consider the original question. The original questions says, Mr. Speaker — get this — a detailed outline from the Department of the Environment on how the Government of Saskatchewan plans to dispose of all wastes resulting from uranium mining and refining in Saskatchewan; a detailed outline for what the Government of Saskatchewan says, or it is alleged, it says, is responsible for disposition of the wastes.

Well it is difficult to amend the question, that kind of a question, with that all-embracing a field, but I think I have an amendment, Mr. Speaker. I have an amendment, after a great deal of thought on this, which should satisfy all the members opposite.

I would like to move, seconded by the Provincial Secretary (Mr. Cowley) that all the words after the word 'showing' be deleted and the following substituted therefor:

The manner in which the Government of Saskatchewan implements the most stringent regulation of uranium development anywhere in Canada, and outlines the measures for making licences public and regulating wastes generated by industry in uranium mining and milling operations.

Amendment agreed.

Motion as amended agreed.

Return No. 502

MR. G.S. MUIRHEAD (**Arm River**) moved, seconded by the member for Wilkie (Mr.Garner) that an order of the Assembly do issue for Return No. 502 showing:

Documents from (a) the Department of Health (b) the Department of Labour, and (c) the Department of the Environment showing all the rules and regulations pertaining to radiation control in the province of Saskatchewan as of March 1, 1980.

Motion agreed.

Return No. 169

MR. J.W.A. GARNER (Wilkie) moved, seconded by the member for Bengough-Milestone (Mr. Pickering) that and order of the Assembly do issue for Return No. 169 showing:

All studies, surveys, questionnaires, correspondence, reports, memoranda, aide-memoires, recommendations, and any other documents of the Department of Health with regard to the consent of minors with respect to the health care act.

MR. ROMANOW: — Mr. Speaker, I'm going to ask the members of the House to turn down this proposed Order No. 169. There are two reasons for my urging this. The first reason is perhaps in the area of trivia, although I don't think so. It's a valid point. So far as I know — I stand to be corrected here — we don't have a health care act in the province of Saskatchewan. The question asks for studies and surveys, etc. with regard to health care act as it relates to minors. We don't have one in the province of Saskatchewan, so even if we were inclined to answer it I guess we would answer nil because there is no health care act.

But it doesn't matter because the principle — and this is my second reason — for this order for return is one that asks for all studies, surveys, questionnaires, correspondence. All correspondence, Mr. Speaker, get this, including correspondence for or against people write to a minister or write to a department expressing their views! They would now have that correspondence revealed — reports, memoranda, aide-memoires — any kind of an aide-memoire that a minister would have made in the course of a conversation with an individual — recommendations, and any other documents (just in case they haven't covered the waterfront) of the Department of Health with regard to the consent of minors with respect to the health care act which is nonexistent. I stand to be corrected and I apologize if that is the case.

So I say, Mr. Speaker, that it's imply a wrong principle to do this, to table it. We've never done this before. These are internal documents which are used by the government and the department in the formulation of policy. Not only that, but it's so sweeping and so wide it would be dangerous and unwise for us to adopt the motion as proposed.

So, Mr. Speaker, I'm recommending defeat in item 209, proposed Return No. 169.

MR. GARNER: — Mr. Speaker, I'll withdraw that and work it up and bring it back in a different form. I would also like to withdraw the next one, number 210, Return No. 170, as well.

Motions for Return Nos. 169 and 170 withdrawn.

Return No. 171

MR. G.S. MUIRHEAD (**Arm River**) moved, seconded by the member for Wilkie (Mr. Garner) that an order of the Assembly do issue for Return No. 171 showing:

The name, department and position of every person who was not covered under the Saskatchewan Government Employees' Association contract who received remuneration from the Government of Saskatchewan for services rendered to the Government of Saskatchewan during the period beginning midnight November 15, 1979 and ending at midnight December 4, 1979.

MR. ROMANOW: — Mr. Speaker, I think by now it will be obvious to all members of this Assembly what's been transpiring here all day and basically all sitting evening with respect to these motions for returns and proposed questions. The point I want to make is that these question are asked in areas of concern which will be very difficult, if not impossible, for the government to answer. I invite again the members of this Assembly to consider this question which is before us. The question says the member wants the name, department and position of every person who is not covered under the Saskatchewan Government Employees' Association contract who received remuneration from the Government of Saskatchewan for services rendered during the period of November 15 to December 4, 1979.

By the way, Mr. Speaker, I think we can notice that period is the period during which there was disruption and a cessation of work as a result of a dispute involving the Saskatchewan Government Employees' Association and the public service commission. I'll say a word or two about that in a moment. But even if we could answer this question, what this question gets at and what it would have us do is to list the names of all the people who are not covered by the SGEA contract who receive remuneration from the Government of Saskatchewan.

Mr. Speaker, I don't know if the framer of this question stopped for one moment to think of the consequences of what this question wanted to uncover, because if that individual had, somewhere in the back room of the Leader of the Progressive Conservative Party's offices, he would have surely realized the answer would obligate the government to list here the names, departments and positions of all people who are temporary employees, or part-time employees who have not worked long enough to qualify as SGEA members — probably amounting into the hundreds — casual employees who are not covered by the contract, members of CUPE which is another union not covered by the SGEA contract but covered in a collective bargaining agreement with the government (I don't know for sure, but my estimate is there would be probably 400 workers or more just for the CUPE bargaining units alone), out-of-scope employees, those who are not covered by any SGEA contract and so forth I don't know how much time, how much effort would be involved to answer that, but I would predict without any fear of contradiction, Mr. Speaker, it would be an inordinately large amount of time and effort — extra effort, I remind the members of the House, at taxpayers' expense — to table this kind of information.

Why was it asked, Mr. Speaker? This brings me to my second point. Why was it asked when I think — and this is my second point — the obvious intent of this motion is to try to get at — I say it is the intent — those workers who during the course o the dispute with SGEA, saw fit to return to work during the period of the dispute November 15 to midnight, December 4, 1979. You will recall, Mr. Speaker, that at the fall session of the legislature a question of this same nature was asked by the opposition, the PC opposition, and we were dealing with it at that particular time. I say there can be no other motivation behind such a question.

The hon. member for Maple Creek says it's ridiculous. If the answer is that there is another motivation for it, why is it that the dates are so particularly identified as between November 15 and December 4, 1979? I ask you if there is such a discussion in the legislature here, to take judicial notice of the fact that this was the exact period of the dispute — what they want is those people who returned to work not covered by the

SGEA contract. I don't think they realize that their net cast such a broad scope and caught so many other people such as CUPE and casuals and part-times and those who were not in SGEA membership because of the fact of the 30-day waiting period and so forth, even if we could answer it on that kind of a basis. But I say, Mr. Speaker, that what this really involves is an attempt to witch hunt, to witch hunt the number of people who took a position one way or the other during the course of the SGEA dispute.

Mr. Speaker, I make no mistake about it. This is the second question of this nature which has been put forward by the PC caucus and they want to find out what the answers are and the names and the positions in the departments. What are they going to do with this information, Mr. Speaker? How are they going to handle it? Where will this information come out? What approach will the opposition take once this information is provided to them? I say, Mr. Speaker, that it is absolutely essential to keep these questions in proper perspective.

I don't think the Liberal opposition, if they had been in this legislature at this time (if I may say comparing from my experience) would have shown the lack of attention that this motion, this order for return, does — casting such a broad net and thereby gathering in the names of innocent people or a number of people who are not related at all to this issue. What other possible conceivable reason could there be for getting this information? I invite the hon. members sometime later on during the course of the debate to explain to this House what the conceivable reason and motivation would be. Why would he motivate this to November 15 and December 4, 1979? I say that the logical conclusion is that this is an attempt — pure, simple, blatant, bold-faced attempt to get at the information related to the people with respect to the SGEA dispute.

I say, Mr. Speaker, that this is a very lamentable position to be taken by the opposition. I say, Mr. Speaker, that tonight if we assess all of the orders for return that we have now filed in this Assembly ...We have gone through maybe about one-third of them, Mr. Speaker, there is another half to two-thirds yet to be tackled let alone those that are adjourned at the next private members' day and probably the next private members' day after that, given the contention of them.

I say that all of this shows the highest degree of irresponsibility on the part of the opposition; because, Mr. Speaker, if one had taken this particular motion and done one's homework with respect to the issues and the answers sought, you wouldn't have these kinds of wide nets which indeed have been cast with the tremendous costs and expenses which will be attached to the taxpayers of the province of Saskatchewan.

I think, Mr. Speaker, that the PC opposition has shown itself to be bankrupt of new ideas by this order for return. The PC opposition has proven itself to be bankrupt politically. Mr. Speaker, I would say the PC opposition has proven itself to be totally bankrupt — period — with respect to this session. And, Mr. Speaker, I think I've been around this Assembly — if I keep this up for a little while longer, I may end up being the dean. Oh, it's the member who does all the talking from the seated position in the House, but from a standing position outside the House . . . Sometime I'd like to welcome him into a formal debate inside the House. It would be nice to know what allegations he makes in this House rather than standing up there outside the legislature and doing that.

So I say to the hon. members opposite — to each and every one of them — they should be ashamed at the effort hat has been put forward in this regard.

Now I don't know if I'd single out the hon. member for Arm River personally for this kind of a motion because I don't think he knew what he signed when he submitted this order for return. I think some poison pen writer or researcher in the back of his office gave him, like everybody else, a whole series of these questions on the order paper. Mr. Speaker, they gave no thought to what they were asking. They did not want to give any time to the research of the operation. They simply said this was the case.

Mr. Speaker, what are we hiding, the hon. members say. The hon. members who were in the House today and tonight and the press will know we have agreed to virtually all of these motions for return — all of them.

AN HON. MEMBER: — With amendments.

MR. ROMANOW: — Yes, with the amendments, necessary amendments for question which if we'd adopted as answered would have provided a nil answer, time after time after time. Amendments in order to make the questions proper for the PC caucus . . . (inaudible) . . .

SOME HON. MEMBERS: — Hear, hear!

MR. ROMANOW: — That's the kind of co-operation we give them. Mr. Speaker, the people of Saskatchewan want this PC opposition to elevate its sights away from these kinds of motions and questions. It's high time to start talking policy. Mr. Speaker, the members of this Assembly want to know where the PCs stand on uranium; where they stand on right to work; where they stand on direct billing; where they stand on developments; where they stand on Crown corporations and not to go on witch-hunting with respect to the SGEA employees. It's high time the PCs told us where they were.

SOME HON. MEMBERS: — Hear, hear!

MR. ROMANOW: — It's high time Mr. Devine took charge of this runaway caucus which puts motions like this before us. Mr. Speaker, it's high time there was a leader of the PC Party to look as this motion and say to the caucus, hold it boys, you're misdirecting your efforts. It' high time that situation be put in here. I say, Mr. Speaker, when you see the kind of leaderless, rudderless, directionless kind of approach by the PC caucus that indeed the taxpayers of Saskatchewan, and only the taxpayers of Saskatchewan, are going to pay the penalty for that.

SOME HON. MEMBERS: — Hear, hear!

MR. ROMANOW: — Now, Mr. Speaker, I'm going to have a lot more to say about this because this is an example of what I want to say. Therefore I beg leave to adjourn the debate.

SOME HON. MEMBERS: — Hear, hear!

Debate adjourned.
