employed by the local government board who were: (1) permanent, (2) casual or seasonal, (3) on contract and the nature of the contract, (4) permanent out-of-scope and their names and positions.

Amendment agreed.

Motion as amended agreed.

The Assembly adjourned at 9:56 p.m.
