The Speaker: — The Chair recognizes the member for Indian Head-Milestone.

Provision of Oxygen for Cancer Patients

Mr. McMorris: — Thank you, Mr. Speaker. My question is short and simple. Can the minister tell this Assembly, Minister of Health tell this Assembly how his government and Sask Health defines palliative care?

The Speaker: — The Chair recognizes the Minister of Health.

Hon. Mr. Taylor: — Mr. Speaker, I think the member opposite has a dictionary and whatever the definition in the dictionary would probably fit Sask Health.

The Speaker: — The Chair recognizes the member for Indian Head-Milestone.

Mr. McMorris: — Thank you, Mr. Speaker. Mr. Speaker, 55-year-old Linda Stonehouse lives in Arborfield. Last August, she was given 9 to 12 months to live. She has lung cancer. Linda has frequent episodes of extreme shortness of breath and difficulty breathing. Her family physician and the oncologist said she requires oxygen to avoid these episodes, yet Sask Health will not allow the cancer clinic to provide oxygen free of charge because Linda is not considered in the end stage of palliative care.

Mr. Speaker, why is this system denying terminal cancer patients comfort in their last few months?

The Speaker: — The Chair recognizes the Minister of Health.

Hon. Mr. Taylor: — Thank you very much, Mr. Speaker. The regions and the agencies have responsibility for the day-to-day administration of care. Mr. Speaker, each of the regions and the agencies have quality of care coordinators who deal directly with patients and families on matters like this.

Mr. Speaker, I have confidence in the quality of care coordinators within the cancer agency and within the regions and I would ask the member opposite to ensure that the family and the patient take this matter up with those who are best qualified to deal with it at the local level.

The Speaker: — The Chair recognizes the member for Indian Head-Milestone.

Mr. McMorris: — Well, Mr. Speaker, that's exactly what the family has done. Linda's daughter, who's in the gallery today, has called both the quality care coordinator and the patient advocate at the Canadian Cancer Society. Both said that giving oxygen would be the suitable and compassionate thing to do. But they could not help in this situation so they referred the family to Saskatchewan Aids to Independent Living, or SAIL. Linda's physician wrote SAIL requesting oxygen. The organization denied the doctor's request. Linda only has a few months to live and cannot afford the oxygen that both her physician and the oncologist have recommended.

Mr. Speaker, to the minister again: can the minister tell us why terminal cancer patients who are considered at the end stage of palliative care are being denied oxygen by Sask Health as requested by their physician and oncologist?

The Speaker: — The Chair recognizes the Minister of Health.

Hon. Mr. Taylor: — Thank you very much, Mr. Speaker. The program that the member opposite talks about, SAIL, has been serving Saskatchewan residents for a number of years. It has very specific guidelines that it works with, Mr. Speaker. I urge the member opposite in his consultation with the family and I urge the family to continue working through the processes that are in place to see that assessments are done properly and that whatever guidelines are in place are followed as requested.

The Speaker: — The Chair recognizes the member for Indian Head-Milestone.

Mr. McMorris: — Mr. Speaker, it's that minister's guidelines that has brought their family, Linda's family, to the Assembly today. When Linda Stonehouse has an episode, she must be rushed to the nearest hospital to get oxygen in the emergency room. That means, in Linda's case, a frantic 45-minute drive to Nipawin, which is stressful for Linda and her family. Not only does that result in increased cost to the system because Linda is now in the emergency room, it's not a very good environment when her immune system is depressed.

Mr. Speaker, Linda's doctors say that having oxygen at home would allow her quality of life for the time that she has left. At only \$250 a month, that's minimal cost to the health care system. Mr. Speaker, will the minister commit today to reviewing his own department's policies when it comes to oxygen for cancer patients when they're in the end stage of palliative care?

The Speaker: — The Chair recognizes the Minister of Health.

Hon. Mr. Taylor: — Thank you very much, Mr. Speaker. I think the member opposite knows that we are constantly and continually reviewing policies and guidelines. We do so during the course of the year when cases are brought to our attention that may require some changes in guidelines, and we do it every year in the budget building process.

Mr. Speaker, I would urge the member opposite to ensure that when he has matters like this come to his attention, that he ensure that my office is aware of matters like this when he finds out about them, so that we might take action if we're in a position to do so as quickly as possible. **The Speaker**: — The Chair recognizes the member for Indian Head-Milestone.

Mr. McMorris: — Mr. Speaker, we're asking the minister today to review his policy and change the guidelines that are set out for SAIL because they're just not acceptable.

Linda's family is frustrated. They believe that if the doctor has ordered oxygen for a patient that the system shouldn't be able to deny that request, especially when it's a patient with terminal cancer. Linda's family is saying denying her of oxygen is taking away her ability to function as best as she can these last few months, to spend quality time with her family and grandchildren, again during these last few months.

Will the minister do the right thing, the sensible and compassionate thing, and provide oxygen to terminal cancer patients who require it?

The Speaker: — The Chair recognizes the Minister of Health.

Hon. Mr. Taylor: — Thank you very much, Mr. Speaker. And again I indicate to the member opposite that when matters are brought to our attention we, whether it's internal to the Department of Health or whether it's to the minister's office, when matters are brought to our attention we review them with the intention of looking at guidelines and processes.

I also indicate to the member opposite that there are guidelines and processes that have been in place, have served to provide services to Saskatchewan people for quite a number of years, and that continue in their state of evolution, and get changed when matters allow them to be changed or when resources permit.

Again I suggest to the member opposite that when he heard about this case he should have brought it to our attention immediately, and we would have begun review on the case earlier than he's suggesting today.

The Speaker: — The Chair recognizes the member for Batoche.

Condition of Highway 368

Mr. Kirsch: — Thank you, Mr. Speaker. Mr. Speaker, it's spring now in Saskatchewan which means one thing. We see the crumbling roads of this province, the demolished and unsafe highway that this NDP [New Democratic Party] government presides over, Mr. Speaker.

One of my constituents has come to me with huge concerns over Highway 368 from St. Brieux to Muenster. His name is Don Folden and he is with Tillage Tools. He says the road is impassable which causes a problem, Mr. Speaker, since Bourgault Industries, Ag Solutions, Dry Air, Tillage Tools, and Assie Industries ship millions of dollars worth of equipment from this town and employ hundreds of people.

Mr. Speaker, the minister even promised last year that he would go and visit to see for himself how bad this highway is. I quote from Hansard, November 29, 2005:

... my commitment is that we'll attempt to be out there shortly ... I'm hoping we can do it before Christmas.

But he still hasn't gone, Mr. Speaker. My question: when does the minister expect to have Highway 368 fixed so all the industries and all their employees do not have to risk their own personal safety?

Some Hon. Members: — Hear, hear!

The Speaker: — The Chair recognizes the Minister of Highways and Transportation.

Hon. Mr. Lautermilch: — Well, Mr. Speaker, I want to say to that member and to members of the legislature that he is correct. It is spring. And with spring brings thaw, and with the thawing of roads brings heaves and potholes. It's an annual event, Mr. Speaker. And the member from Cannington obviously has some thoughts on this regard and if he wants to get up and ask me a question he can do so after I've done my response, but I'd appreciate his attention while I'm attempting to answer.

Mr. Speaker, the Department of Highways this year has a record amount within its budget — \$345 million which is a 15 per cent increase. But I want to say to all members of the House, in northern Saskatchewan we've got particular conditions caused by high moisture levels, high water levels, and it is raising havoc with our highways. Highway 969 is one example and I can give him others besides the one he raised. The department is working on these.

Some Hon. Members: — Hear, hear!

The Speaker: — The Chair recognizes the member for Batoche.

Mr. Kirsch: — Thank you, Mr. Speaker. Mr. Speaker, the story of economic development in St. Brieux is a David versus Goliath story; one small town fighting against a monolithic, old NDP government. And this small town prevails by building some of the most successful businesses in the province that employ hundreds and pour thousands of tax dollars into provincial coffers. You'd think the government could fix their road. But this minister refuses because Highway 368 is not on the department's 2006 or 2007 highway construction schedule.

Mr. Speaker, this NDP government has a mountain of extra cash and they give nothing back to those who create jobs and pay taxes. Mr. Speaker, when will the minister commit to giving the citizens of St. Brieux a decent, safe highway?

Some Hon. Members: — Hear, hear!

Mr. Kirsch: — Why has this NDP government not given this area a decent road?

Some Hon. Members: — Hear, hear!

The Speaker: — The Chair recognizes the Minister of Highways and Transportation.

Hon. Mr. Lautermilch: — Mr. Speaker, it's obvious that that member has taken rhetoric lessons from the Leader of the Opposition. He's learning quite quickly.

Mr. Speaker, as the members will know, Department of Highways and contractors will get to the roads as they can when moisture conditions will allow.

Mr. Speaker, the Department of Highways officials, I think, do a very good job on behalf of the people of Saskatchewan. Weather conditions sometimes disallow the work to be done when that member may want to have it done or when we would want to have it done.

I can say, Mr. Speaker, that with respect to this particular road, I will check with the department to see what kind of attention it's going to receive and when it will, and I promise that member I'll report to him directly.

Some Hon. Members: — Hear, hear!

The Speaker: — The Chair recognizes the member for Batoche.

Mr. Kirsch: — Thank you, Mr. Speaker. Mr. Speaker, I'd like to bring to the minister's attention, as well as the Premier, that their offices are about to be flooded with letters from angry residents of St. Brieux and Lake Lenore.

Scott Lessmeister told the *Humboldt Journal* this morning, and I quote:

[I'm] asking everyone to write a letter to government officials, including [the] Minister of Highways Eldon Lautermilch and Premier Lorne Calvert...

Mr. Speaker, the people are fed up with this government, are demanding action be taken. But this NDP government has turned their back on the citizens of St. Brieux. Mr. Lessmeister says, "The more letters we can send, the more ammunition the Opposition has to pressure the government on this issue. Let's help them help us."

Mr. Speaker, can the minister — or better yet the Premier — explain to Mr. Lessmeister why he won't fix Highway 368? Can the Premier tell him and all the other residents why they must risk personal injury in order to leave their home? What . . .

The Speaker: — Member's time has elapsed.

Some Hon. Members: — Hear, hear!

The Speaker: — The Chair recognizes the Minister of Highways and Transportation.

Hon. Mr. Lautermilch: — Mr. Speaker, I want to say to that member that I certainly do appreciate his questions, because it does create awareness. And I want to say that this is an annual event in the spring. The roads will deteriorate and we will wait for the right conditions to get the reconstruction crews out to be able to do the work. And, Mr. Speaker, this spring is no different.

But what I would want to create is a little awareness from members of the opposition. They now are so closely tied to their federal counterparts in Ottawa. There was a budget put down by the federal government just a couple of days ago. And I'd like to ask that member if he has bothered to sit and write a letter to his federal counterparts in Ottawa to see what they might want to do about a national highways program that this country very much needs that would allow us to focus on other areas of need as well, Mr. Speaker.

Some Hon. Members: — Hear, hear!

The Speaker: — The Chair recognizes the member for Canora-Pelly.

Terms of Appointment at Labour Relations Board

Mr. Krawetz: — Thank you, Mr. Speaker. Mr. Speaker, my question is to the Minister of Labour. It's been 24 hours since I drew to his attention allegations of political interference raised by the former Vice-Chair of the Saskatchewan Labour Relations Board.

Working men and women in our province must know their rights are being protected by an independent board. Men and women willing to invest in our province and create jobs must also know that there is a level playing field. Mr. Speaker, in the last 24 hours what has the Minister of Labour done to investigate these very serious allegations of political interference in the Labour Relations Board?

Some Hon. Members: — Hear, hear!

The Speaker: — The Chair recognizes the Minister of Labour.

Hon. Mr. Forbes: — Thank you very much, Mr. Speaker. Let me be clear. There is no political interference in the workings of the Labour Relations Board. I want to also remind and inform the members of this House and the people of Saskatchewan, the former Vice-Chair of the Labour Relations Board finished his term, his appointment. On February 28, 2006, he completed it.

Mr. Speaker, I am deeply concerned about the allegations that were made in this House and not made outside the House. This is very troubling about the kind of way the members opposite, the Sask Party, operates. They work within the protection of this House, but yet refuse to make the same allegations outside.

Some Hon. Members: — Hear, hear!

The Speaker: — The Chair recognizes the member for Canora-Pelly.

Mr. Krawetz: — Mr. Speaker, Mr. Matkowski makes serious allegations. The former Vice-Chair, Mr. Speaker, the former Vice-Chair of Labour Relations Board alleges he was removed from his job because rulings angered unions. Mr. Matkowski states, and I quote:

On June 24, 2005, Craik [that is deputy minister of Labour, William Craik] telephoned me and advised me that I would not be reappointed on March 1, 2006, and that he thought I should resign . . . Craik advised me that some

of the unions had been complaining about my decisions. I asked Mr. Craik what were the Unions saying about me, and he would not say, advising me that this was "hearsay". I stated to him that it was obviously effective hearsay, to which he agreed.

Mr. Speaker, what has the minister done to investigate these serious allegations of political interference?

Some Hon. Members: — Hear, hear!

The Speaker: — The Chair recognizes the Minister of Labour.

Hon. Mr. Forbes: — Mr. Speaker, we are on the same fishing trip we were on yesterday. I have some serious concerns about the allegations that are raised inside this House but won't be raised outside this House. The Vice-Chair's term expired on February 28, 2006. He completed his term. Mr. Speaker, I have some real serious concerns about the credibility of the members opposite.

Some Hon. Members: — Hear, hear!

The Speaker: — The Chair recognizes the member for Canora-Pelly.

Mr. Krawetz: — Thank you, Mr. Minister. Mr. Speaker, this matter can be cleared up in a few minutes. All the minister has to do is talk to his deputy minister — in fact the very gentleman that was here last night. All the minister has to do is ask Mr. Craik if he told the Vice-Chair of the Labour Relations Board that Mr. Matkowski would not be reappointed as he requested because the unions didn't like his rulings.

Some Hon. Members: — Hear, hear!

The Speaker: — The Chair recognizes the Minister of Labour.

Hon. Mr. Forbes: — Mr. Speaker, I have been assured, and I believe there has been no political interference. But yet again I will say, the Vice-Chair's term expired on February 28, 2006. He completed his work. And that is a fact, Mr. Speaker.

I am deeply concerned about the way the members operate, making allegations inside this House but not willing to make the same allegations and quote the same document outside this House.

Some Hon. Members: — Hear, hear!

The Speaker: — The Chair recognizes the member for Canora-Pelly.

Mr. Krawetz: — Mr. Speaker, the affidavit of Mr. Matkowski was clearly outside of this House and we read from it yesterday, Mr. Speaker. I can't believe that the Minister of Labour won't take a very simple step. He won't ask the deputy minister of Labour what happened.

Mr. Speaker, is this minister completely uninterested in the political independence of the Labour Relations Board? Or does he not want to hear the answer? Mr. Speaker, when will this minister give these allegations of political interference the

serious attention that they deserve?

Some Hon. Members: — Hear, hear!

The Speaker: — The Chair recognizes the Minister of Labour.

Hon. Mr. Forbes: — Mr. Speaker, we of course take this very seriously, these questions of allegations. And of course the member opposite uses the word affidavit. I find that very interesting. Will he call it outside the House an affidavit? Outside the House he calls it a document. Here is a document that ... unsigned. We need to have more details here. Why won't he quote from the document outside, Mr. Speaker?

Here we have folks like that working from a document like that, calling into question the work of Legal Aid Commission, the prosecutions branch. This is the way these folks operate over here. And I'm very concerned about credibility, Mr. Speaker. Who has any credibility when they operate like that?

Some Hon. Members: — Hear, hear!

The Speaker: — The Chair recognizes the member for Canora-Pelly.

Mr. Krawetz: — Mr. Speaker, perhaps the Minister of Labour doesn't want to confront the deputy minister of Labour because this minister is still relatively new to his portfolio. Perhaps he should ask his cabinet colleague, the former minister of Labour for her assistance in this matter.

Mr. Speaker, it is alleged this interference took place in June 2005. Mr. Speaker, will the current Minister of Labour undertake to ask the former minister of Labour if the Vice-Chair of the Labour Relations Board was asked to resign and was not to be reappointed because, quote, "... some of the unions had been complaining ..."?

What will he say about his decision?

Some Hon. Members: — Hear, hear!

The Speaker: — The Chair recognizes the Minister of Labour.

Hon. Mr. Forbes: — Thanks very much, Mr. Speaker. I find this passing strange. We were in estimates last night. We could have had this question in estimates here.

But, Mr. Speaker, I want to assure the members there has been no political interference. But really the question is, why is the member here operating from a position of political protection and won't go outside and make these same allegations, Mr. Speaker? If there's ever a question of credibility, that member suffers from that.

Some Hon. Members: — Hear, hear!

The Speaker: — The Chair recognizes the member for Canora-Pelly.

Mr. Krawetz: — Thank you, Mr. Speaker. Well, Mr. Speaker, yesterday when I quoted from the affidavit of Mr. Walter Matkowski, I stated very clearly that that was his affidavit.

These were concerns that he raised. And in fact, Mr. Speaker, when I presented that document to the press, members of the press, two of the members phoned Mr. Matkowski and Mr. Matkowski's lawyer to verify that in fact this was his affidavit. So these are his words, Mr. Speaker. They're not my words. They're Mr. Matkowski's words who alleges that there was interference.

Can the minister stand in this Assembly and say that Mr. Matkowski's allegations of political interference are wrong?

Some Hon. Members: — Hear, hear!

The Speaker: — The Chair recognizes the Minister of Labour.

Hon. Mr. Forbes: — Thank you very much, Mr. Speaker. I think I've answered that question in terms of political interference. I've answered it several times. But the member opposite, the critic, continues to dodge the question about, will he take these allegations and be specific in here, out there?

I am very concerned about the kind of attacks that these folks undertake against the people in Saskatchewan that make sure labour laws are followed. This is a very important board that we have and the credibility and the nature of the board must be protected. And here we have a member attacking it. This concerns me very much.

Some Hon. Members: — Hear, hear!

The Speaker: — The Chair recognizes the member for Canora-Pelly.

Mr. Krawetz: — Thank you, Mr. Speaker. Mr. Speaker, the minister in an earlier response indicated that the member of the board, Mr. Matkowski, had finished his term. And I want to read from The Trade Union Act, section 1.2 of clause 4, that says:

If the term of a member of the board expires after the member has begun hearing a matter before the board but before the proceeding is completed, the member may continue as if his or her term had not expired for the purpose of completing this proceeding.

The Speaker: — Order please. Order. Order. The member for Canora-Pelly.

Mr. Krawetz: — Thank you, Mr. Speaker. Mr. Speaker, can the minister after having read Mr. Matkowski's affidavit in which Mr. Matkowski says, and I quote from page no. 4, that "... Mr. Craik had instructed that I no longer be scheduled as Vice Chair."

That is a statement made on July 12, 2005. Can the minister state that there was no political interference by the deputy minister of his department?

Some Hon. Members: — Hear, hear!

The Speaker: — The Chair recognizes the Minister of Labour.

Hon. Mr. Forbes: — Mr. Speaker, let's review the facts. The person in question completed his term the end of February — February 28, 2006. It was a complete term. And as the member opposite read out the quote, the operative word was may. As I stated yesterday that's the operative word, may.

Now, Mr. Speaker, the member opposite has on several occasions now taken fishing expeditions attacking several different people. And we're concerned about that. Mr. Speaker, the member opposite, and frankly the whole opposition, suffers from a real lack of credibility.

Some Hon. Members: — Hear, hear!
