

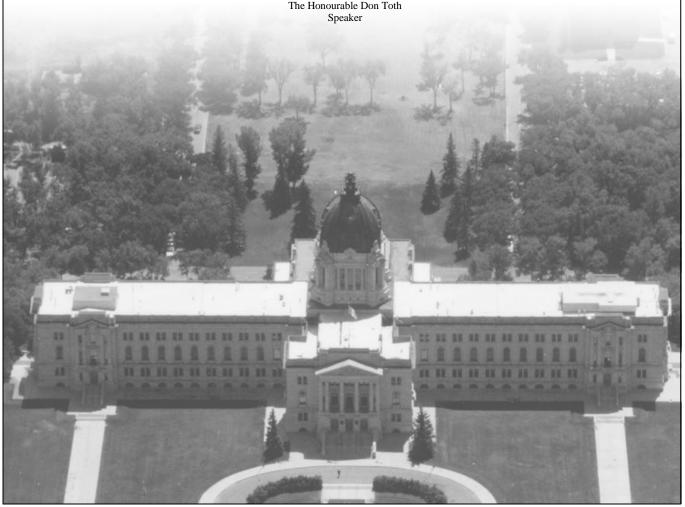

#### INTRODUCTION OF GUESTS

**The Speaker**: — I recognize the member from Regina Rosemont.

**Mr. Wotherspoon:** — Mr. Speaker, to you and through you it's certainly my pleasure and my honour to introduce a very important and special guest to myself here in the Assembly today, and that would be my mother, seated up in your gallery.

It's a pleasure to introduce Captain Wes Gramiak, detachment commander, Canadian Forces recruiting detachment, Saskatoon. Captain Gramiak is also Chair of the Central Saskatchewan Military Family Resource Centre in Dundurn. Joining him is Master Corporal Tom Kennedy who is also here today with us in the House. He is with the air traffic control section at 15 Wing in Moose Jaw and chairs the Moose Jaw Military Family Resource Centre. Also with us today is Mr. Regan Gorski. He is the executive director of the Central Saskatchewan Military Resource Centre in Moose Jaw, and finally — last but not least — Richard Cuttell, executive director of the Central Saskatchewan Military Family Resource Centre in Dundurn.

Mr. Speaker, these gentlemen have provided each member of this Assembly with a yellow Support Our Troops lapel pin, and I hope all members will wear these pins with pride.

"The Festival draws people from all across Saskatchewan, as well as visitors from around North America," said Lyle Bolen, president of the festival. He notes that the festival's community engagement, artistic diversity, and strong growth, as well as the many economic benefits it delivers to Saskatchewan builds a vibrant cultural community in Saskatchewan.

Mr. Speaker, I ask all members join me in congratulating the SaskTel Saskatchewan Jazz Festival on yet another great year. Thank you very much, Mr. Speaker.

**The Speaker**: — I recognize the member from Wood River.

### **Severance Package**

**Mr. Huyghebaert**: — Well, Mr. Speaker, the cover-up continues. Now the NDP is refusing to release the letter it sent authorizing a \$131,000 severance payment to former NDP chief of staff, Jim Fodey. What are they hiding? If they've been telling the truth about Mr. Fodey's departure, what are they hiding? If Mr. Fodey is truly entitled to this \$131,000 severance payment, then what are they hiding?

Mr. Speaker, the NDP covered up the truth about their caucus fraud scandal 16 years ago, and they're still doing it today. The NDP claim to be concerned about openness and accountability. They claim to be concerned about the government changing the approval process for contracts over \$50,000, yet they flat out refuse to release the letter authorizing this huge severance payment to an NDP staff member who supposedly resigned. Typical NDP, say one thing and do another.

Mr. Speaker, the NDP has turned a \$6,000 fraud scandal and cover-up into a \$131,000 bill to Saskatchewan taxpayers. At the very least, they owe Saskatchewan people an honest explanation. They owe Saskatchewan people the truth. Will the Leader of the Opposition show that he actually still is the leader of the party, do the right thing, and release the letter? If not, what are they hiding?

### **Allegations of Conflict of Interest**

**Ms. Higgins:** — Thank you very much, Mr. Speaker. Mr. Speaker, SaskTel employees and the people of Saskatchewan have some questions for the minister about his plans for SaskTel.

The official opposition has been told that SaskTel is diverting all SaskTel Max and high-speed Internet installation services to Jump.ca. Can the minister confirm that Jump dot will be taking over SaskTel Max and high-speed installation and inform the House whether he or the board made the decision?

Some Hon. Members: — Hear, hear!

**The Speaker**: — I recognize the Minister Responsible for Crown Corporations.

Some Hon. Members: — Hear, hear!

**Hon. Mr. Cheveldayoff:** — Thank you, Mr. Speaker. I can assure the hon. member that I didn't make no such decision.

**The Speaker**: — I recognize the member from Moose Jaw Wakamow.

**Ms. Higgins:** — Well, Mr. Speaker, as a result of the contract, Jump.ca is benefiting from new business being directed its way. As the minister surely knows, the chairperson, Grant Kook, who the minister appointed as Chair of the SaskTel board, is also the CEO [chief executive officer] of Golden Opportunities Fund.

The Golden Opportunities Fund has \$2 million invested in Jump.ca. Well Golden Opportunities prospectus states that the fund manager is eligible for financial incentives if the fund does especially well.

To the minister: the board Chair that the minister appointed has the potential to benefit financially from any move that sees business go to Jump.ca. What does the minister say about this possible conflict of interest?

Some Hon. Members: — Hear, hear!

**The Speaker**: — I recognize the Minister Responsible for Crown Corporations.

Some Hon. Members: — Hear, hear!

**Hon. Mr. Cheveldayoff:** — Thank you, Mr. Speaker. I can tell all members of this Hon. Assembly that Mr. Grant Kook does run Golden Opportunities, a labour-sponsored venture capital fund in Saskatchewan. It has about \$100 million under administration. His fund has benefited Saskatchewan in many, many ways.

I was very, very pleased when we approached Mr. Kook and asked him to extend his public service to Saskatchewan people by accepting the very important job of Chair of SaskTel's board of directors. I can assure the member opposite that Mr. Kook's intentions are to benefit Saskatchewan and to benefit SaskTel in every endeavour.

Some Hon. Members: — Hear, hear!

The Speaker: — I recognize the member from Moose Jaw Wakamow.

Ms. Higgins: — Well, Mr. Speaker, Grant Kook is not the only one with a financial interest in Jump.ca. And according to the April 20, 2007 public disclosure statement, the minister responsible for the Crown holds investments in the Golden Opportunities Fund. As I've mentioned, Golden Opportunities is set to profit from work diverted to the SaskTel, a Crown that the minister is responsible for.

Mr. Speaker, my question is simple. To the minister: how does he explain his possible conflict of interest?

Some Hon. Members: — Hear, hear!

**The Speaker**: — I recognize the Minister Responsible for Crown Corporations.

Some Hon. Members: — Hear, hear!

**Hon. Mr. Cheveldayoff**: — Mr. Speaker, I can tell the members opposite and all members of this Hon. Assembly that yes, I am one of the holders of the Golden Opportunities Fund which is one of two labour-sponsored venture funds in Saskatchewan that benefit our entire province.

I can tell the hon. member that there's many, many thousands of individuals who have benefited from their management and also many companies within Saskatchewan who have benefited from this. I am very surprised at the line of questioning, and I would be interested to see if the member opposite will be following this line of question outside the House.

**Some Hon. Members**: — Hear, hear!

**The Speaker**: — I recognize the member from Moose Jaw Wakamow.

Ms. Higgins: — Well, Mr. Speaker, the many, many thousands of investors in Golden Opportunities are not the ministers responsible for SaskTel. So let's recap, Mr. Speaker. In January the Minister Responsible for the Crowns appointed Grant Kook as the SaskTel board Chair. Mr. Kook is CEO of the Golden Opportunities Fund which has \$2 million invested in Jump.ca.

We've been told Jump.ca is to perform all future SaskTel Max and high-speed Internet service installations. That work could greatly improve the profits of Jump.ca and therefore the Golden Opportunities Fund which the minister also has investments in, according to public records.

To the minister: there are lots of unanswered questions about what, if any, conflict of interest may be at work here. And what is the minister going to do about it?

**Some Hon. Members**: — Hear. hear!

**The Speaker**: — I recognize the Minister Responsible for Crown Corporations.

**Some Hon. Members**: — Hear, hear!

**Hon. Mr. Cheveldayoff:** — Thank you, Mr. Speaker. I can assure the hon. member that yes, I do have shares within Golden Opportunities and they have been properly disclosed with the Conflict of Interest Commissioner. And I would hazard to guess that probably most members of this Assembly share that investment as well.

I can tell the member opposite that I also have investments within Potash Corporation, Cameco, and other Saskatchewan ... because I believe in Saskatchewan and that's where I believe that the money should be put to work. And I can assure the member that there is no conflict of interest, perceived or otherwise, in regards to those funds.

Some Hon. Members: — Hear, hear!

**The Speaker**: — I recognize the member from Prince Albert Northcote.

### **Funding for the Arts**

Mr. Furber: — Mr. Speaker, unfortunately for the people of our province, the minister's three and a half million dollar slush fund, developed at the expense of the Saskatchewan Arts Board, doesn't only affect the Arts Board. Because of these cuts the Saskatchewan Motion Picture Association also will see its operation budget reduced. Additionally, we've learned that SMPIA's [Saskatchewan Motion Picture Association] proposal for funding of a career development program has been declined. Mr. Speaker, SMPIA is an organization that has helped promote, develop, and maintain our film industry in our province for over 20 years.

To the minister: with \$2 billion in the bank, why would she make cuts to an organization that's vital to the film industry in our province?

**Some Hon. Members**: — Hear, hear!

**The Speaker**: — I recognize the Minister Responsible for Tourism, Parks, Culture and Sport.

**Some Hon. Members**: — Hear, hear!

**Hon. Ms. Tell:** — Thank you for the question. In response to the issue with cutting of Crew Call, it is our determination in

the ministry that SaskFilm is our lead agency on training initiatives for people within the film industry. We are taking the lead. We believe that SaskFilm is the one to offer that particular program, and they do so quite adequately.

**Some Hon. Members**: — Hear, hear!

**The Speaker:** — I recognize the member from Prince Albert Northcote.

**Mr. Furber**: — It's not ironic that this news comes as a surprise to SaskFilm. It's the way they've developed their programs — on the fly.

Mr. Speaker, it looks like a three and a half million dollar slush fund wasn't enough for the minister. Now she's taking funding away from an industry in our province that's in the middle of unprecedented growth. They're not shy about their beliefs that the arts community shouldn't get funding from government, but cutting money to an ed program in a non-profit organization goes beyond that to destructive. Mr. Speaker, this isn't about budgetary constraints or the need for a framework; it's about her ideology.

To the minister: will she restore funding that was taken from a vital industry in our province? Will she restore the funding she's cut from SMPIA?

Some Hon. Members: — Hear, hear!

**The Speaker**: — I recognize the Minister Responsible for Tourism, Parks, Culture and Sport.

Some Hon. Members: — Hear, hear!

**Hon. Ms. Tell:** — Mr. Speaker, as I have said before in this House that we are as a ministry stepping back involving . . . We're going to involve stakeholders within the industry for consultations to ensure that we put together a proper framework to ensure the viability of the arts and cultural sector in this province.

We are also following a direction as provided by the Saskatchewan Institute of Public Policy to develop this framework, because this province under that government did not, did not have a proper framework. Mr. Speaker, we are taking it on good authority that what we are doing is the right thing to do, to step back and take a thoughtful approach to this very vital industry to ensure sustainability into the future, Mr. Speaker.

Some Hon. Members: — Hear, hear!

**The Speaker:** — I recognize the member from Prince Albert Northcote.

Mr. Furber: — Well, Mr. Speaker, this is beginning to look like a pattern. In one year, they sabotaged status of the artist legislation. They've ripped three and a half million dollars dedicated to the Saskatchewan Arts Board so that the minister can develop a slush fund. And now, while this government sits on over \$2 billion, they've cut funding for ed programs at SMPIA, programs that have been offered for nearly a decade. It

certainly hasn't taken long for the Saskatchewan Party to show their contempt for arts and culture in our province.

To the minister: what other organizations is she targeting? What other groups are on her funding cut hit list?

Some Hon. Members: — Hear, hear!

**The Speaker**: — I recognize the Minister Responsible for Tourism, Parks, Culture and Sport.

Some Hon. Members: — Hear, hear!

**Hon. Ms. Tell:** — Mr. Speaker, our commitment in the platform just prior to the election was that we were going to ensure and maintain funding to the arts and cultural sector. Promise made, promise kept, Mr. Speaker.

Some Hon. Members: — Hear, hear!

**The Speaker**: — I recognize the member from Regina Dewdney.

### Personnel Changes in the Public Service

Mr. Yates: — Mr. Speaker, we have been asking questions since day one about long-time civil servants and their treatment by this government. Mr. Speaker, many civil servants that were let go by this government have not yet been afforded fair severance packages, and the government refuses to negotiate in good faith with these individuals, Mr. Speaker, forcing them to go to the courts to look for settlement.

To the government: why are you refusing to negotiate with these civil servants in a fair and equitable manner?

Some Hon. Members: — Hear, hear!

The Speaker: — I recognize the Deputy Premier.

Some Hon. Members: — Hear, hear!

**Hon. Mr. Krawetz**: — Thank you, Mr. Speaker. Mr. Speaker, the member opposite knows full well that individuals who are released because of a change of government, who are released without cause, have rights to severance packages. Those severance packages are negotiated between legal people that will be hired by the individual involved or by the government.

These negotiations are continuing, Mr. Speaker. There may be some impasses and someone decides that they wish to go to a court of law. That is the rights within a democratic society, Mr. Speaker.

Some Hon. Members: — Hear, hear!

**The Speaker**: — I recognize the member from Regina Dewdney.

**Mr. Yates**: — Mr. Speaker, the Sask Party has a habit of appointing their friends to high places. Many of those friends are from the former Devine administration. Gren Smith-Windsor was appointed by the government as acting

deputy minister of Health. Many questions about the appointment were asked by many people, especially since his termination as CEO of the Prince Albert Parkland Health Region in 2005.

The Premier defended that decision by saying it was not a permanent appointment but simply an acting position until they did a national search for a deputy minister. To the government: will the new deputy minister be appointed soon or is the government simply going to appoint Gren Smith-Windsor to this position?

Some Hon. Members: — Hear, hear!

**The Speaker**: — I recognize the Minister of Health.

Some Hon. Members: — Hear, hear!

Hon. Mr. McMorris: — Thank you very much, Mr. Speaker. I believe in the fall session these questions were asked at that time and answered at that time. An acting deputy minister has been appointed for the Ministry of Health replacing long-serving John Wright, absolutely. A search has been taking place over the last number of months, a nationwide search. And I believe that the list has been shortened and I think a permanent deputy minister for Health will be named very soon.

Some Hon. Members: — Hear, hear!

**The Speaker**: — I recognize the member from Regina Dewdney.

Mr. Yates: — Mr. Speaker, we understand the Ministry of Social Services is not filling vacant positions in income security. The minister's failed attempt at restructuring may have caused her some budgetary problems. Will the minister commit to filling those vacancies or is she using the vacancies as a backdoor method to follow through with her plan of restructuring?

Some Hon. Members: — Hear, hear!

**The Speaker**: — Before I recognize ... Order. Before I recognize the minister, I just want to remind members to direct the questions through the Chair. I recognize the Minister of Social Services.

Some Hon. Members: — Hear. hear!

**Hon. Ms. Harpauer**: — Thank you, Mr. Speaker. I have taken direction from my deputy minister when vacancies need to be filled. I have done nothing to fill positions or prevent them from being filled.

**Some Hon. Members**: — Hear, hear!

**The Speaker**: — I recognize the member from Regina Dewdney.

**Mr. Yates**: — Mr. Speaker, the civil service continues to wait for the next round of firings to occur. They know the end is not yet here. To the government: when can we expect the next round of civil service firings?

**Some Hon. Members**: — Hear, hear!

**The Speaker**: — I recognize the Deputy Premier.

**Some Hon. Members**: — Hear, hear!

**Hon. Mr. Krawetz**: — Mr. Speaker, as I've indicated in this Assembly many times, the initial transition phase is primarily over. We have asked ministers who are now reviewing staff, who are reviewing vacancy positions that have occurred, Mr. Speaker . . . In the entire civil service, both within the Crowns and within the government ministries, there are over 20,000 employees, Mr. Speaker. And through a process of attrition, through a process of retirement, there is about a change of 1,500 employees on an annual basis, Mr. Speaker. So that means over 100 changes are made monthly.

So, Mr. Speaker, there will be changes. I can assure the member opposite there may be changes within ministries in terms of people who are evaluated by the deputy ministers and by the process that's in place. And the members will find out if those changes will occur over the course of time.

Some Hon. Members: — Hear, hear!

**The Speaker**: — I recognize the member from Regina Dewdney.

**Mr. Yates**: — Thank you very much, Mr. Speaker. The Deputy Premier indicates to us that the transition phase is primarily over, Mr. Speaker. Well that doesn't give a lot of people great comfort, Mr. Speaker. Could he please define for us what primarily over means?

Some Hon. Members: — Hear, hear!

**The Speaker**: — I recognize the Deputy Premier.

Some Hon. Members: — Hear, hear!

**Hon. Mr. Krawetz**: — Thank you, Mr. Speaker. Mr. Speaker, we know that the former government, the NDP, in 1991 I think, took about two and a half years to complete their transition phase, Mr. Speaker — two and a half years. So for that member to stand there and say what does primarily mean, it means that the transition team is nearly finished.

There are still some evaluations that are taking place. There are still some positions that need to be filled, Mr. Speaker. And those will continue under the direction of the Deputy Premier and the Premier as we work towards creating a civil service in this province that we can be proud of, Mr. Speaker.

Some Hon. Members: — Hear, hear!

**The Speaker**: — I recognize the Leader of Her Majesty's Loyal Opposition.

#### **Gasoline Prices**

**Mr. Calvert**: — Mr. Speaker, we interestingly heard last week that despite having promised when in opposition to cut the gas tax in the province of Saskatchewan if the world price of oil

exceeded \$60 a barrel, now apparently the government does not believe that it needs to be concerned about the price of gas at the pumps.

In the meantime, Mr. Speaker, we've got analysts telling us that the gas prices are projecting upwards. And we learned over the course of the weekend, Mr. Speaker, that in fact pump measurements in this country, in this province may not be in fact accurate.

Well last week the Minister of Finance told the House that he and his government were monitoring the situation. Well I'll tell you what, Mr. Speaker. As the Minister of Finance monitors his growing treasury, people's pocketbooks are being squeezed. So my question is for the Premier: how high does the price of gas need to be before his government will take some action?

Some Hon. Members: — Hear, hear!

**The Speaker**: — I recognize the Premier.

**Some Hon. Members**: — Hear, hear!

**Hon. Mr. Wall:** — Well, Mr. Speaker, I want to thank the hon. member for the question. First of all, we are seeing certainly higher energy costs right across the piece. There are higher utility bills being dealt with by people across the country. And certainly gas prices are on the rise.

We here in Saskatchewan are fortunate to at least partially benefit from high energy costs because, of course, the hon. member is right — revenues to the government increase. This government is carefully monitoring the situation. This government is committed to this basic principle, that the people of the province should and will share in the prosperity of Saskatchewan, that this government will use those revenues to make important investments — like \$60 million today for the St. Mary's School and an affordable housing project and, yes, like relief for Saskatchewan families.

There will be the opportunity perhaps for long-term debt reduction. These issues I know our MLAs are going to be talking about throughout the summer. And I'm interested in some more specific ideas from the opposition as well. How much would they like the gas tax to be reduced? And what else, what other ideas do they have for the revenue the province now sees?

**Some Hon. Members**: — Hear, hear!

**The Speaker**: — I recognize the Leader of the Opposition.

Mr. Calvert: — Well, Mr. Speaker, oh how, oh how things have changed. Back when the price of gas, Mr. Speaker, when the price of gas was just peaking over \$1, here's what the Sask Party members opposite had to say. The Minister of Enterprise and Innovation said, quote, "Saskatchewan motorists are upset and angry about high gas prices." The Minister of Government Services said, quote, "The government is getting rich from oil revenues, but Saskatchewan drivers are getting nailed every time they go to the pumps." And the Leader of the Sask Party,

now Premier said, quote, "Saskatchewan people deserve a break"

Well it's apparent they'll say anything in opposition; and now in government, it's do nothing. So the Premier apparently has dropped his plan to reduce the provincial gas tax. Does he have a plan then to help people who are struggling — whether they be families, whether they be farmers, whether they be business people — does he have a specific plan to help people with the high cost of fuel?

Some Hon. Members: — Hear, hear!

**The Speaker**: — I recognize the Premier.

Some Hon. Members: — Hear, hear!

Hon. Mr. Wall: — Well, Mr. Speaker, I thank the hon. member for the question. I can remember when those debates were taking place here in the Legislative Assembly. The opposition at the time came forward with some very specific ideas, some specific numbers. We did quite say, very publicly by the way, and apparently with the agreement of the NDP, that gas tax relief was not perhaps the best way to provide relief for Saskatchewan people. It neither sent the right message with respect to conservation and the environment, and neither did it provide broad-based relief for Saskatchewan people who face high costs.

But at the time there was some specific proposals put forward by this party. So I'd ask the hon, member again, he must certainly have a specific proposal in mind. If he has changed his mind, if he has changed his mind and now believes that this kind of relief is the right kind of public policy alternative, we'd like to hear the specifics.

In the meantime, in the meantime Saskatchewan families are benefiting from a government that's committed to fixing the infrastructure deficit we inherited from there. Mr. Speaker, we're also demonstrating, even today, we are committed to ensuring that the people of his constituency at St. Mary's School, through housing and a brand new school, share in the prosperity of Saskatchewan.

Some Hon. Members: — Hear, hear!

**The Speaker**: — I recognize the Leader of the Opposition.

**Mr. Calvert**: — Mr. Speaker, this morning I wrote a letter to the Prime Minister of Canada. I said to the Prime Minister in my letter, about the same time this Premier was promising to cut the gas tax for motorists in Saskatchewan, the Prime Minister was . . .

**The Speaker**: — I recognize the Leader of the Opposition.

Mr. Calvert: — Mr. Speaker, at the same time this Premier, now Premier, was promising to cut the gas tax for Saskatchewan motorists, his friend Stephen Harper was committing the federal Conservative Party to reducing the GST [goods and services tax] on the amount of the cost of a litre of gas, anything over 85 cents.

So I've written the Prime Minister this morning to say it's about time he kept his promise and give even this small bit of relief to the motorists of Canada, the motorists of Saskatchewan. Furthermore, I've said to the Prime Minister that it seems to us appropriate that all of the fuel tax being collected by the federal government in Saskatchewan ought to be returned to the people of Saskatchewan for our infrastructure and the maintenance of our highways.

Mr. Speaker, then I ask the Premier, would he do this much? Would he join with me today in contacting his friend Stephen Harper, the Prime Minister of Canada, demanding that the Prime Minister at least keep his promise to the people of Canada and return to the people of Saskatchewan all of the fuel taxes that is being collected in our province?

Some Hon. Members: — Hear, hear!

**The Speaker**: — I recognize the Premier.

Some Hon. Members: — Hear, hear!

Hon. Mr. Wall: — I want to thank the hon. member for the question. We certainly agree that a tax on a tax is not the right practice for any government. In fact I remember prior to being chosen as leader of the opposition, as an MLA I wrote a similar letter to the minister at the time, the Finance minister, Mr. Martin. And of course no change was forthcoming. The change has not yet occurred. And certainly applying the GST to other fuel taxes doesn't make a lot of sense.

I note that the hon. member has said he also put in his letter how he wants the federal government to make sure that the money from the federal tax stays in the province. And, I mean, certainly this idea has some merit as well.

But I'm not sure that's the right member to write that letter because it is the history of that party and that leader that they would take this gas tax from Saskatchewan motorists — in the millions and millions of dollars — but they would not put it in the highways in the province. And so we were left with that billion dollar pothole people talked about in the campaign.

I would point out, Mr. Speaker, that the people of the province appreciate this government's approach, for every dime of gas tax and more will go to fix the roads in Saskatchewan.

Some Hon. Members: — Hear. hear!

**The Speaker**: — I recognize the Leader of Her Majesty's Loyal Opposition.

**Mr. Calvert**: — Mr. Speaker, the Premier may want to be reminded that it is the law in Saskatchewan that every cent of fuel tax collected goes to the highways — that law put in by the New Democratic Party government.

Some Hon. Members: — Hear, hear!

**Mr. Calvert**: — Mr. Speaker, this Premier will say anything in opposition and now when consumers in this province — you name it, families, working people, farmers, business people, people looking forward to summer vacation — are facing these

kinds of prices at the pumps; we've apparently got pumps that aren't measuring properly; we've got a federal government that won't keep its promise.

Will he not, at least, today join us — he can phone, he can write — contact the federal government, lower that GST and give us back the money that's being collected in Saskatchewan? Will he at least do that much?

Some Hon. Members: — Hear, hear!

**The Speaker**: — I recognize the Premier.

**Some Hon. Members**: — Hear, hear!

Hon. Mr. Wall: — Well, Mr. Speaker, the budget is full of measures that this government has taken to make sure that the people of Saskatchewan are sharing in the prosperity that we see. It was in this budget where we saw an historic \$5 million investment to food banks and CBOs [community-based organization] to invest in life skills and employment training. It is in this budget where we saw an historic investment with respect to addictions treatment, an historic investment in school facilities, an historically large investment in health care facilities.

Mr. Speaker, it was in this government's budget . . . well in fact it was this government's action today with respect to next year's budget, that we would fix a problem that has gone unattended by now two successive former premiers who represented Riversdale, and that's a brand new school at St. Mary's, and a brand new affordable housing project, Mr. Speaker, for that particular constituency.

All of that at a time of unprecedented growth that should have members opposite a little happier than they are, frankly. The job numbers are out. We broke another record, over 8,000 new jobs. We're leading in export, not just the rest of the country—we're beating Alberta while the other country's actually backing up. This is the place to be—in Saskatchewan right now—and the only group that hasn't figured it out is the members opposite.

Some Hon. Members: — Hear, hear!
