International Day of Persons with Disabilities

Mr. Forbes: — Thank you, Mr. Speaker. Today, December 3, is International Day of Persons with Disabilities, a very special day declared by the United Nations in 1992 to promote awareness of disability issues and abilities of people with disability.

Dignity and Justice for All of Us is this year's theme, a very timely and important message as it has been estimated that 10 per cent of the world's population, or 650 million people, live with disabilities, and tragically 80 per cent of whom live in poverty. We must break this cycle of poverty and disability.

Mr. Speaker, the United Nations, in celebrating this day as well as the 60th anniversary of the Universal Declaration of Human Rights next week, is using a theme, Dignity and Justice for All of Us, as a rallying call as these principles are far from being realized for everyone.

Dignity and justice are embodied in the civil, cultural, economic, political, and social rights promoted by the convention. Therefore now is the time to make a renewed commitment to the ratification and full implementation of the Convention on the Rights of Persons with Disabilities and its optional protocol. We would add our voice to urge both the federal and provincial governments to do all they can to ensure quick ratification of the convention and its optional protocol as the best vehicle to ensure full and fair participation of all citizens in our society.

Saskatchewan Residents Teach Egyptian Children

Ms. Schriemer: — Mr. Speaker, I rise today with pride to share with you and this House a story of two of my constituents. One of the things that I find most interesting and satisfying as an MLA [Member of the Legislative Assembly] is that this job allows you to share in the lives of people you serve. It allows you to listen to their stories, both happy and sad.

The people that I speak about today, Mr. Speaker, are Delmar and Betty Rempel. Del and Betty are without a doubt two of the most gentle, caring, hospitable, and spiritual human beings that I've ever met. Their story is about touching the lives of children in Egypt.

Multicultural Council Director Becomes a Mentor

Tara's 65-page submission for accreditation was completed on her own time and was designed to show her proficiencies in the required areas. These included a minimum of seven years experience and a minimum of 200 hours of documented training related to settlement work.

Tara will become part of a Saskatchewan team that will mentor and assist other settlement workers to complete application for accreditation. The process serves to further professionalize the settlement sector and thereby provide consistent and standardized services to all new Canadians.

Their reputation for providing great service to immigrants making Moose Jaw their home is well known. Not only do they welcome the new residents, but they also have available settlement programs, language classes, a host program, employment services, and a child care facility. Wickenheiser Centre in Shaunavon

Shaunavon is a community where eight-year-old Hayley

She has reached the pinnacle of success, all the while remaining a lifelong ambassador for the community of Shaunavon.

Proposed Land Sale

Ms. Morin: — Mr. Speaker, the media reported yesterday that more than 41 000 hectares of land in northwestern Saskatchewan will be put up for auction next Monday by Saskatchewan Energy and Resources. It was also reported that several environmental organizations have reached an agreement with forest company Mistik Management and the Ministry of Environment's lands branch to designate the area in question as a protected site. It seems that in this Sask Party government, the left hand doesn't know what the right hand is doing. To the minister: why is the Sask Party auctioning land that the Ministry of Environment says should be protected?

Some Hon. Members: — Hear, hear!

The Speaker: — I recognize the Minister Responsible for Energy and Resources.

Hon. Mr. Boyd: — Thank you, Mr. Speaker. We are aware of the Saskatchewan Environmental Society's concerns with respect to this. Resource development in Saskatchewan will go forward as always, in the most environmentally responsible and sustainable way that we can have it done. The criteria of course for this government in terms of resource development is environmentally responsible development, socially responsible development, and of course economically responsible development.

So the concerns of the Saskatchewan Environmental Society came to light here a couple of days ago. We are looking into the areas of interest to them, and we'll certainly be making representations back.

Some Hon. Members: — Hear, hear!

The Speaker: — I recognize the member from Regina Walsh Acres.

Ms. Morin: — Mr. Speaker, we already know the Sask Party doesn't listen to forest companies and forest communities when it comes to the future of their industry. Now we know that they also don't listen to the forest companies when they recommend designating areas as protected sites.

Mr. Speaker, the agreement between Mistik Management, several environmental NGOs [non-governmental organization], and the province was a product of a lot of co-operation on all sides. Now everyone's wondering why the Sask Party has thrown a monkey wrench into the things at the last minute.

To the minister: why is the Sask Party so deaf to any recommendation that comes out of the forestry industry?

Some Hon. Members: — Hear, hear!

The Speaker: — I recognize the Minister Responsible for Energy and Resources.

Hon. Mr. Boyd: — Well, Mr. Speaker, to the member, clearly that's not the case. We have said all along that development has to take place in an environmentally responsible fashion, a socially responsible fashion. The area in question that the member brings to everyone's attention here was not designated as a protected area. The Environmental Society is suggesting that maybe it should be; that's a suggestion that we are willing to take a look at, and we certainly will.

Some Hon. Members: — Hear, hear!

The Speaker: — I recognize the member from Regina Walsh Acres.

Ms. Morin: — The clock is ticking, Mr. Speaker. Saskatchewan Environmental Society executive director, Allyson Brady, told *The StarPhoenix* that the way this is being handled is quote "... highlights the fact this is happening in an ad hoc, unplanned, irresponsible way."

Mr. Speaker, the Sask Party is missing an opportunity here to provide certainty to businesses and assurances to stakeholders who try to engage in responsible land use, and that their planning work won't be in vain.

To the minister: why is the Sask Party undermining people who have made the effort to work co-operatively to resolve these issues?

Some Hon. Members: ---- Hear, hear!

The Speaker: — I recognize the Minister Responsible for Energy and Resources.

Hon. Mr. Boyd: — Mr. Speaker, any successful land development or oil and gas development or mining development must go through a very rigorous authorization through the Ministry of Environment and the Ministry of Energy and Resources. That's been the process that's been adopted by this government, followed by the previous administration as well.

The same designation that was asked for in this one is being looked at, is also the same designation that Oilsands Quest got that the former administration put in place at that time. Exactly the same process today, Mr. Speaker.

But in terms of any kind of development going forward or anything of that nature, in terms of being irresponsible, what is really irresponsible in Canada today or in Saskatchewan today is an opposition opposite that wants to take the government of the day in Ottawa down. They want to fall in bed with the separatists in Quebec today...

The Speaker: — The minister's time has elapsed.

Some Hon. Members: — Hear, hear!

The Speaker: — I recognize the member from Regina Walsh

Acres.

Ms. Morin: — Political grandstanding is going to be cold comfort to the people that are worried about these Canada protected sites, Mr. Speaker. Mr. Speaker, there's a lot of urgency to this issue. The sale in question is planned for Monday, the Monday coming up. The window of opportunity to act is closing. The Ministers of Environment and Energy and Resources have just two days to come up with a solution. So let's help them along, Mr. Speaker, by proposing one right now.

To the Minister of Energy and Resources: yes or no, will he defer any sale of the land in question until the land in question has been designated as a protected site?

Some Hon. Members: — Hear, hear!

The Speaker: — I recognize the Minister Responsible for Energy and Resources.

Hon. Mr. Boyd: — Mr. Speaker, the last authorization in this area for oil and gas development was authorized by your party. The last one that came forward was to the Oilsands Quest. It was the same kind of environmental protection plan authorization and exactly the same kind of procedure that we are following that you, on that side of the House, followed at the time.

But in terms of any kind or irresponsibility, Mr. Speaker, in terms of irresponsibility, the last thing that we'll take lessons from is the NDP [New Democratic Party] opposite. The fact of the matter is, is that they are supporting the separatists in this country today. They are authorizing coalition meetings across this province today in Saskatchewan, Mr. Speaker. The fact of the matter is, is we are in favour of a duly...

The Speaker: — Order. The minister may finish his response.

Hon. Mr. Boyd: — The fact is, Mr. Speaker, in Saskatchewan to date people are looking at the situation in Ottawa and saying, where does the Government of Saskatchewan stand? Well clearly the Government of Saskatchewan stands on the side of the duly elected government, not on the side of the people who want to overthrow the government of this country, Mr. Speaker, as is the members that are . . .

Home Ownership Programs

Mr. Forbes: — Thank you, Mr. Speaker. We all know Saskatchewan is facing a labour shortage and one of the best ways to address that shortage is to ensure that Saskatchewan people can find an affordable place to live. One way to ease this pressure on the rental housing market is to give long-time renters a chance to own their own home. But the government's programs to encourage home ownership ran out of money earlier this year and the Sask Party has failed to put more

money in. They're missing an opportunity to give low-income families a chance to own their own home and at the same time reduce the pressure on the rental housing market that keeps rents so high.

To the minister: what is her plan to help low-income families who want a chance to own their own home?

Some Hon. Members: — Hear, hear!

The Speaker: — I recognize the Minister Responsible for Social Services.

Hon. Ms. Harpauer: — Thank you, Mr. Speaker. The member opposite should know that when his government was in power and when he was sitting at the cabinet table, they had the neighbourhood home ownership program and they let that program expire and didn't continue. So it was done when he was sitting at the cabinet table, making decisions.

Then on the eve of the election — on the eve of the election; they didn't even get the program going — it was just before the election they announced the home ownership program, which is indeed out of money. And he's right, Mr. Speaker, it is out of money.

It allows people to access money who have incomes up to 50,000. Right now in our housing situation we have to worry about the most vulnerable. We have to look at those that don't even have an income close to \$50,000, Mr. Speaker.

Some Hon. Members: — Hear, hear!

The Speaker: — I recognize the member from Saskatoon Centre.

Mr. Forbes: — Mr. Speaker, this government has still not replaced HomeFirst home ownership program, despite their historic surpluses. And the lack of action really is a missed opportunity. Mr. Speaker, organizations like SHIP [Saskatoon Housing Initiatives Partnership], Regina Rescue Mission, and Sasknative Rentals, among others, have the expertise to manage home ownership and home building programs that meet the needs of their clients.

To the minister: will she commit here today to establishing a CBO [community-based organization] building fund this year so that these organizations can contribute to making home ownership more affordable for Saskatchewan families?

Some Hon. Members: — Hear, hear!

The Speaker: — I recognize the Minister Responsible for Social Services.

Hon. Ms. Harpauer: — Again, Mr. Speaker, I'll point out that the member opposite, who sat at the cabinet table when the NDP were in power, let their existing home ownership program become useless because they didn't adjust it for today's market. On the eve of the election they announced a home ownership program. They didn't worry about it before that. And when they were on the hot seat trying to win an election is when they decided home ownership was an issue. Mr. Speaker, we have the legislation in place. We will be forming a board that's going to look at what will work well within our market as it exists today. But what can he say about his support for his leader? Because we have a commitment by our existing federal government to help fund housing programs. Does he support the coalition that didn't mention housing?

Some Hon. Members: — Hear, hear!

The Speaker: — I recognize the member from Saskatoon Centre.

Mr. Forbes: — Mr. Speaker, we'll put up our record any day of the week against their record. But I'm glad that she brought up \dots

Some Hon. Members: — Hear, hear!

Mr. Forbes: — The housing corporation Act. Well, Mr. Speaker, the vast majority of students are renters. They make up a significant portion of the renters in this province. Measures to help student renters would reduce the pressure on the rental market. We know that for sure.

Now in the past, the minister suggests that student housing is not part of her mandate. But section 19(1) of the Sask housing corporation Act clearly states, and I quote:

The corporation may encourage the construction of student housing or the acquisition of existing buildings and their conversion to student housing in areas where a need can be established for the purpose of providing adequate housing for students.

So, Mr. Speaker, she has a mandate to act. To the minister: given the historic surplus this government enjoys, why is she missing this opportunity to act on student housing?

Some Hon. Members: — Hear, hear!

The Speaker: — I recognize the Minister Responsible for Advanced Education, Employment and Labour.

Hon. Mr. Norris: — Mr. Speaker, thank you very much for the opportunity to highlight important work that's under way regarding student housing, Mr. Speaker. That is most directly, despite the lamentable — lamentable — work that went on on the other side of the aisle, Mr. Speaker.

On this subject what we can say is, on November 21, Mr. Speaker — they might have missed it — on November 21 a 36-family unit was established for the SIAST Woodland Campus, Mr. Speaker, reinforcing support for post-secondary students in safe, affordable, quality homes, Mr. Speaker, a \$3.5 million investment that should be open next fall, Mr. Speaker. That's what we're undertaking, Mr. Speaker.

Some Hon. Members: — Hear, hear!

The Speaker: — I recognize the member from Saskatoon Centre.

Mr. Forbes: - Mr. Speaker, there are a number of

recommendations from the minister's own task force that she has not yet implemented, including measures to increase the supply of affordable rental housing. The minister hints that some of the government's infrastructure money may be used for housing, but then she fails to act. Meanwhile, it's been more than a year, more than a year since any new money has been allocated to build affordable housing.

To the minister: why is the Sask Party missing so many opportunities to act on affordable housing?

Some Hon. Members: — Hear, hear!

The Speaker: — I recognize the Minister Responsible for Social Services.

Hon. Ms. Harpauer: — Mr. Speaker, I have said it in the House before and I will say it again — because the member opposite cannot remember from one day to the next what has been said — there are 935 units that are in various stages of development since November 2007. Some of them are student housing, Mr. Speaker. We announced student housing. He obviously missed that press release, Mr. Speaker.

But what is his record? He said that he will just stand by his record. Well his record did nothing about shelter rates, which helps the most vulnerable within our society. We acted on the task force immediately. We increased the shelter rates. We indexed their shelter rates. We increased the rental supplement and we indexed it as well. And, Mr. Speaker, we'll continue to help those that are most vulnerable in our society, unlike the member opposite who sat at the cabinet table and for 13 years they increased shelter rates by \$5.

Some Hon. Members: — Hear, hear!

The Speaker: — I recognize the member from Regina Coronation Park.

Proposed Sale of Crown Subsidiary

Mr. Trew: — Thank you, Mr. Speaker. Mr. Speaker, the Minister Responsible for CIC [Crown Investments Corporation of Saskatchewan] has said that his plan to hold a fire sale of Crown assets is not based on ideology. He says the government will only sell off those investments that are not directly benefiting the people of Saskatchewan. But in his recent news release the minister says he's looking at selling off DirectWest, the Saskatchewan phone book company.

Mr. Speaker, to the minister: how does the Sask Party selling DirectWest meet any criteria that is not driven simply by blind ideology?

Some Hon. Members: ---- Hear, hear!

The Speaker: — I recognize the Minister Responsible for Crown Corporations.

Hon. Mr. Cheveldayoff: — Mr. Speaker, as I have had the chance to articulate in this House before, the Sask-first policy is

one that's well regarded across Saskatchewan, highlighted by the investment by this government into SaskTel of some \$90 million for a \$130 million program. We didn't hear from the opposition if that was a good program or a bad program. They seemed to agree with it but, Mr. Speaker, it is possible because we are getting out of money-losing ventures outside of Canada and putting that money to work here in Saskatchewan.

Some Hon. Members: — Hear, hear!

The Speaker: — I recognize the member for Regina Coronation Park.

Mr. Trew: — Well, Mr. Speaker, DirectWest employs about 120 people in Saskatchewan. Their head office is located right here in Regina. The phone books are developed and printed in Saskatchewan. The company sponsors more than 75 community groups throughout the province. Mr. Speaker, every aspect of DirectWest is about making life better for Saskatchewan people.

So again to the minister: how does this company that employs people directly and indirectly, supports the economy of Saskatchewan, how does that meet any criteria that isn't simply naked ideological?

Some Hon. Members: — Hear, hear!

The Speaker: — I recognize the Minister for Crown Corporations.

Hon. Mr. Cheveldayoff: — Mr. Speaker, we've been clear with the people of Saskatchewan. Money-losing ventures that are operated under the Crown corporations will be no more. DirectWest Canada and its operation have not contributed to the well-being of the overall Crown corporation.

And as far as naked ideology goes, Mr. Speaker, there is no greater threat to any Crown corporation, to the people of Saskatchewan or their financial well-being, than the Bloc-Liberal-NDP coalition that is threatening our country today, Mr. Speaker.

Some Hon. Members: — Hear, hear!

The Speaker: — I recognize the member for Regina Coronation Park.

Mr. Trew: — Bizarre, Mr. Speaker. DirectWest has been publishing phone books in Saskatchewan for more than 50...

The Speaker: — Order. I recognize the member for Regina Coronation Park.

Mr. Trew: — Mr. Speaker, DirectWest has 50 years of local investment. And according to the minister's SaskTel latest annual report, on page 47, just to help the minister, "The most significant contributor to the increase in other revenues was DirectWest . . ." So much for money-losing ventures, Mr. Speaker. This is one of the most profitable subsidiaries of SaskTel — one of the most profitable, Mr. Speaker — and has a long history of being so.

To the minister: why is he selling off a profitable company that employs hundreds of people in the province of Saskatchewan and has a record of more than 50 years of doing so?

Some Hon. Members: — Hear, hear!

The Speaker: — I recognize the Minister Responsible for Crown Corporations.

Hon. Mr. Cheveldayoff: — Mr. Speaker, unlike members opposite, this government has listened to what Saskatchewan people wanted. They wanted enhanced cellular coverage across Saskatchewan. They wanted enhanced high-speed Internet across this province, so every resident, whether rural or urban — we know what they thought of rural Saskatchewan — where every resident in urban or rural Saskatchewan has the same opportunity to start their small business, to have the education that they want. That's our commitment, to do it here in Saskatchewan. We will use the resources of SaskTel and this government to ensure that that happens, Mr. Speaker.

Some Hon. Members: — Hear, hear!

The Speaker: — I recognize the member for Regina Coronation Park.

Mr. Trew: — Thank you, Mr. Speaker. The business community simply rejects the arguments that this minister is making. And I want to quote from *The StarPhoenix* editorial dated October 30. And I quote, quote:

What Mr. Cheveldayoff ordered this week seemed more like ordering Crown executives to employ meat tenderizer mallets on the companies until they are soft enough to be sold . . .

Is the minister telling us these business commentators have got it all wrong? Or is he going to reverse his blind ideological drive to sell off our Crowns?

Some Hon. Members: — Hear, hear!

The Speaker: — I recognize the Minister Responsible for Crown Corporations.

Hon. Mr. Cheveldayoff: — Mr. Speaker, it's very clear the opposition has not got any traction on any issues in this whole entire session. They're going back to questions that they asked at the very beginning of the session.

Just to remind you of those questions and the responses from the members opposite. The former premier and the critic had talked about, oh there's nothing new in the Saskatchewan-first policy. We're just doing what we already said we would do back in 2005. Well they had one sleep, Mr. Speaker, and what did they do? They decided that they're against the Saskatchewan-first...

The Speaker: — Minister Responsible for Crown Corporations.

Hon. Mr. Cheveldayoff: — Mr. Speaker, they had one sleep to think about it, and then they decided that they're against the

Saskatchewan-first policy.

Well, Mr. Speaker, we've had a chance to implement the results of that Sask-first policy by the \$130 million commitment that we put towards SaskTel. We've heard resounding results of that from people across Saskatchewan. It's the best announcement that they've heard from a Crown corporation in a long, long time, Mr. Speaker.

I remember to the time, Mr. Speaker, when the member from Saskatoon Nutana had a sign that she went up and said, don't sell our Crowns. Well today she should have a different sign: don't sell our country.

Some Hon. Members: — Hear, hear!

The Speaker: — I recognize the member from Regina Dewdney.

Professional Public Service

Mr. Yates: — Mr. Speaker, the Sask Party election platform pledged to ensure, quote "... [that] promotion in the public service is based on merit, not patronage." And the Premier made statements to the effect, on August 2007, while he was still leader of the opposition, telling the *Leader-Post* that any changes to the civil service would "... be based on merit, not patronage or partisan politics."

These are fine words, Mr. Speaker, but the Minister of Agriculture has suggested that promises made in opposition are not always honoured in government. So to the Minister of the Public Service Commission: does the minister still support the principle of a professional, non-partisan public service?

Some Hon. Members: — Hear, hear!

The Speaker: — I recognize the Minister of Highways and Transportation.

Hon. Mr. Elhard: — Mr. Speaker, that is a very interesting question. It's a very interesting question coming from a group of men and women who sought to let go literally hundreds of people without cause during the tenure of their government.

The question really is, did they believe in a professional public service and, if so, why did they treat their public employees in that way?

Some Hon. Members: — Hear, hear!

The Speaker: — I recognize the member from Regina Dewdney.

Mr. Yates: — Mr. Speaker, within weeks of the election they dismissed more than 70 public servants. The Deputy Premier justified the firings by claiming quote, "... all those dismissed — even those without identifiable political connections — did not fit with the direction and philosophy of the new government."

A few weeks ago, we revealed the Sask Party has already spent more than \$4 million of taxpayers' money for civil servants

they fired, and will likely spend millions more. To the minister: if the Sask Party believe in a professional public service, why have they dismissed long-time public servants without cause and at great expense to the public?

Some Hon. Members: — Hear, hear!

The Speaker: — I recognize the Minister Responsible for the Provincial Secretary, Highways and Infrastructure.

Hon. Mr. Elhard: — Mr. Speaker, the principle of a professional public service is one not only that we subscribe to, but which we are supporting financially. This government promised to commit \$250,000 a year over four years to the Shoyama-Johnson school of public policy. We are following through on that to help develop young people who are going to come in to the public service in this province and possibly in provinces elsewhere.

Mr. Speaker, we have also talked very diligently and directly to the public service about training opportunities and how we want to improve those opportunities for members of the public service across the piece. We have already undertaken some very specific examples of where those opportunities might be obtained outside of the school of public policy.

But, Mr. Speaker, what I'm concerned about is the duplicity and hypocrisy associated with this question. This is coming from a group of men and women who in the years 1992 to 2006 actually let go without cause 645 public servants. Mr. Speaker, that is the rub of this question.

Some Hon. Members: — Hear, hear!

The Speaker: — I recognize the member from Regina Dewdney.

Mr. Yates: — Mr. Speaker, today I am proposing a Bill, the professional public service employees protection Act. The Bill states that every public servant with the exception of those listed may only be terminated for cause. The list of people exempted from the Act's protection includes staff in ministers' offices and Executive Council, and order in council employees hired outside the normal staffing process or at the direction of a minister or the Premier. This Bill provides for clarity that public servants and Saskatchewan people have sought and failed to receive from the Sask Party government.

To the minister: will he support the professional public service employees protection Act, or will he miss an opportunity to give public servants the peace of mind that they deserve?

Some Hon. Members: ---- Hear, hear!

The Speaker: — I recognize the Provincial Secretary, the Minister Responsible for Highways and Infrastructure.

Hon. Mr. Elhard: — Mr. Speaker, thank you. The question, Mr. Speaker, is not so much whether we will respect the public service. The question is, why are they such johnny-come-latelies on this issue? It's really rich for them to present a private member's Bill on the protection of the public service when they were the masters of the fate of 645 public

servants. They were the ones that let go without cause 645 public servants.

Mr. Speaker, let me read into the record, let me read into the record the views of the pretender to the crown over there, Mr. Dwain Lingenfelter:

Cabinet minister Dwain Lingenfelter said the government dismissed Doug Price as president of the Saskatchewan Economic Development Corp., and Leo Larsen as president of STC, in order to replace them with people who better reflect the needs of the government.

Apparently 645 other individuals suffered the same fate.

Some Hon. Members: — Hear, hear!

MINISTERIAL STATEMENTS

The Speaker: — I recognize the Provincial Secretary, Minister Responsible for Highways and Infrastructure.

Capital Plan for Transportation Infrastructure

Hon. Mr. Elhard: — Mr. Speaker, I am pleased to rise today to inform the House that the Ministry of Highways and Infrastructure's five-year rolling capital plan was released this morning. This plan shows forward thinking in infrastructure spending and proves this government's commitment to strategic highway investments.

The rural highway strategy, a critical component of our rolling five-year capital plan, will provide the infrastructure needed to sustain our existing economic activity. This further provides new opportunities for growth by systematically assessing all . . .

The Speaker: — Order. I'll ask members to allow the minister to make his ministerial statement without interference. I recognize the minister.

Hon. Mr. Elhard: — Mr. Speaker, the rural highways strategy uses five criteria to determine the order in which projects will receive funding. Those criteria include the specifics of the engineering economics associated with the road. The necessary services the road provides to communities, such as access to health . . .

The Speaker: — It would be greatly appreciated if members would at least allow the courtesy for the minister to make his statement and then have the response. I'll recognize the minister.

Hon. Mr. Elhard: — Mr. Speaker, the rural highway strategy uses five criteria to determine the order in which projects will receive funding. I've already identified a couple of them. But the third one is the safety and comfort of our travelling public, the impact of the highway in ensuring provincial economic growth now and even more importantly in the future; and lastly, the willingness of communities to be our partners in ensuring their highways meet their immediate and long-term needs for safety and reliability. These are the five items that are weighed

by our panel of transportation experts when they established the plan.

As a component of the rolling five-year plan, the rural highway strategy was developed in collaboration with the Saskatchewan Association of Rural Municipalities as well as the urban municipalities, the area transportation planning committees, the Saskatchewan Economic Development Association, Saskatchewan Tourism, the Saskatchewan Chamber of Commerce, Enterprise Saskatchewan, and industry representatives.

Now one of the most significant aspects of this five-year capital plan is expanding our ability to move more truck freight more efficiently on more Saskatchewan roadways by expanding the primary weight designation of various highway routes. Mr. Speaker, the primary weight system, as a result of this announcement, will increase by over 5 000 kilometres to a total of now 14 400 kilometres. That, Mr. Speaker, is an increase of 53 per cent in total length.

We had previously announced the first two years of the plan, and today the government's new construction project priorities for the next five years were announced. Today's announcement gives the affected communities a tool that they can use to plan for their own growth. It also provides transparency to industry. They now have critical information that they can use to make important investment decisions. And this announcement is a signal to the Saskatchewan road building and construction industries that they can now plan with confidence their future equipment purchases and staffing requirements.

This announcement of the five-year rolling plan is the fulfilment of this government's 83rd election promise and again signals our commitment to the long-term economic prosperity of Saskatchewan. Thank you, Mr. Speaker.

Some Hon. Members: — Hear, hear!

The Speaker: — Before I recognize the member, I think it's unfair for the public when the Minister of Energy and Resources, the Minister of Health, the member from Nutana, and the member from Prince Albert Northcote, after they've been asked to come to order, continue a private dialogue. I would ask members in future to either go behind the bar . . . It's certainly unfair to the members who are speaking. I recognize the member from Regina Northeast.

Mr. Harper: — Thank you, Mr. Speaker. I want to start out by thanking the minister for providing me a copy of his remarks just before entering the House here today.

I think in principle, Mr. Speaker, that the long-term plan for highways construction as announced by the minister is a good plan. It's a good idea. I think it's good for the communities to have an idea what the minister's plans are and priorities are for building. I hope that communities will have the opportunity to influence those plans before they firm up to the point of beyond no return.

I think it's also probably good for the contractors who are looking at making expansions to their equipment and purchasing new equipment and making investments in their businesses to have an idea that they will have a long-term rolling plan here of work into the future. I think they all realize — I think as well as we realize — that the five-year plan is great; only it is subject to each and every year of funding from the budget through the budgetary process.

So what might be the plan might not be reality. It might be influenced by the ability of the province to live with Finance's plans. It's good when you can bring various groups across the province into play here, whether the SARM [Saskatchewan Association of Rural Municipalities] or SUMA [Saskatchewan Urban Municipalities Association] or transportation planning committees, Saskatchewan Economic Development Association, Sask Tourism. All these people have the province at stake, at heart, and the betterment for the province. And I think when you bring these people together and have them working collaboratively and working in one direction, this is truly a good endeavour.

There are some questions that come about as a result of the minister's announcement with the long-term plan now in place, and will this cause ... [inaudible] ... the minister and his department be working with groups out there who may be interested in getting into the construction business? Some new people who may be interested in taking up the occupation of contracting and road building business, will they be working with these people? Will there be more competition at tendering time for these jobs that they tendered out year after year? Will there be an increase in costs of construction? Will this plan simply result in perhaps not more kilometres of road being built, simply more expensive kilometres of road being built?

Those are some of the questions that come to mind. It's interesting, in quickly glancing through the details that the minister released with his announcement, particularly when it comes to the northern transportation strategy. Looking at the plan for the next five years for northern Saskatchewan, we see no mention, no mention of Highway No. 123. That's the highway to Cumberland. We see no mention of that in spite of the fact that my colleague has raised this particular issue and this particular issue of this highway with the minister in this House.

Petitions have been tabled in this House in regards to work to be done on Highway 123. It's a dangerous road. That's been proven with the number of rollovers, the number of injuries, the number of accidents that have resulted in deaths on that road over the years. In spite of the fact that local leaders have been calling for work to be done on this road, the minister has not included it anywhere in the five-year plan. And in some ways, Mr. Speaker, I think this road could be considered a resource road because at the end of this road is the community of Cumberland where there are people, and people are the greatest resource of this province.

Highway No. 10 is not mentioned anywhere in the five-year plan either particularly the stretch from the junction of No. 1 to Fort Qu'Appelle. It's a high-traffic count on this particular stretch of highway. In fact the traffic count on this particular stretch of highway is equal to any of the traffic counts on the highways in Saskatchewan that's being twinned as we speak. It's high tourism traffic on this particular stretch of road, and it's also the main artery for agricultural commodities, agriculturally produced commodities to be transported to three major inland grain terminals. Yet it's not mentioned anywhere in the five-year plan.

Highway No. 7 from Rosetown to the Alberta border, if you've ever had the opportunity to travel that road, you'll know that there's a lot of heavy truck traffic on that road, and quite frankly one has to be on his toes driving that road because it's a scary stretch.

In principle, Mr. Speaker, the five-year rollout plan is a good idea. Unfortunately this particular plan is flawed. It has holes in it that the minister has not been able to address, and I'm hoping that over the next five years the minister will recognize the error of his ways, the inadequacies of this plan, and address them. Thank you.

Some Hon. Members: — Hear, hear!
