Mr. Weekes asked the Government Question No. 63, which was answered by the Hon. Ms. Atkinson:

To the Minister Responsible for Immigration: (1) For the fiscal year 1998-1999, what was the maximum number allowed under the Provincial Immigrant Nominee Program? (2) What was the total number of applications received that year? (3) How many applications received approval?

Answer

- (1) The Canada-Saskatchewan Immigration Agreement, which established the provincial nominee pilot project, was signed September 16, 1998. It permitted a total of 150 nominees for the two-year period ending September 16, 2000.
- (2) From April 1, 1998 to March 31, 1999, 6 applications were received and recorded.
- (3) From April 1, 1998 to March 31, 1999, 5 nominations were approved.

Mr. Weekes asked the Government Question No. 64, which was answered by the Hon. Ms. Atkinson:

To the Minister Responsible for Immigration: (1) For the fiscal year 1999-2000, what was the maximum number allowed under the Provincial Immigrant Nominee Program? (2) What was the total number of applications received that year? (3) How many applications received approval?

Answer:

- (1) The Canada-Saskatchewan Immigration Agreement, which established the provincial nominee pilot project, was signed September 16, 1998. It permitted a total of 150 nominees for the period ending September 16, 2000.
- (2) From April 1, 1999 to March 31, 2000, 50 applications were received and recorded.
- (3) From April 1, 1999 to March 31, 2000, 23 nominations were approved.

Mr. Weekes asked the Government Question No. 65, which was answered by the Hon. Ms. Atkinson:

To the Minister Responsible for Immigration: (1) For the fiscal year 2000-2001, what was the maximum number allowed under the Provincial Immigrant Nominee Program? (2) What was the total number of applications received that year? (3) How many applications received approval?

Answer:

- (1) The Canada-Saskatchewan Immigration Agreement, which established the provincial nominee pilot project, was signed September 16, 1998. The agreement was amended in 2000 to permit 300 nominees for the three-year period ending September 16, 2001.
- (2) From April 1, 2000 to March 31, 2001, 58 applications were received and recorded.
- (3) From April 1, 2000 to March 31, 2001, 20 nominations were approved.

Mr. Weekes asked the Government Question No. 66, which was answered by the Hon. Ms. Atkinson:

To the Minister Responsible for Immigration: (1) For the fiscal year 2001-2002, what was the maximum number allowed under the Provincial Immigrant Nominee Program? (2) What was the total number of applications received that year? (3) How many applications received approval?

Answer:

- (1) The Canada-Saskatchewan Immigration Agreement, which was a provincial nominee pilot project, was signed September 16, 1998. The agreement was amended in 2001 to permit 300 nominees for the four-year period ending September 16, 2002.
- (2) From April 1, 2001 to March 31, 2002, 26 applications were received.
- (3) From April 1, 2001 to March 31, 2002, 25 nominations were approved.

Mr. Weekes asked the Government Question No. 67, which was answered by the Hon. Ms. Atkinson:

To the Minister Responsible for Immigration: (1) For the fiscal year 2002-2003, what was the maximum number allowed under the Provincial Immigrant Nominee Program? (2) What was the total number of applications received that year? (3) How many applications received approval?

Answer:

- (1) A new Canada-Saskatchewan Agreement on Provincial Nominees was signed November 14, 2002. It permits a total of 200 nominees per calendar year or portion thereof, for the period from September 16, 2002 to November 14, 2007.
- (2) From April 1, 2002 to March 31, 2003, 155 applications were received.
- (3) From April 1, 2002 to March 31, 2003, 52 nominations were approved.

Mr. Weekes asked the Government Question No. 68, which was answered by the Hon. Ms. Atkinson:

To the Minister Responsible for Immigration: (1) For the fiscal year 2003-2004, what was the maximum number allowed under the Provincial Immigrant Nominee Program? (2) What was the total number of applications received that year? (3) How many applications received approval?

Answer:

- (1) A new Canada-Saskatchewan Agreement on Provincial Nominees was signed November 14, 2002. It permits a total of 200 nominees per calendar year or portion thereof, for the period from September 16, 2002 to November 14, 2007.
- (2) From April 1, 2003 to March 31, 2004, 232 applications were received.
- (3) From April 1, 2003 to March 31, 2004, 180 nominations were approved.

Mr. McMorris asked the Government Question No. 70, which was answered by the Hon. Mr. Quennell:

To the Minister of Justice: (1) In the Regina area, what was the fee paid by the Coroner's office to "Spectrum Transfer Company" per transfer done in 2002? (2) Is this contract tendered? (3) If not, why not?

Answer:

- (1) \$135 fee per transfer, plus expenses
- (2) No

Ms. Draude asked the Government Question No. 71, which was answered by the Hon. Mr. Cline:

To the Minister Responsible for Saskatchewan Liquor and Gaming Authority: How much money did the Saskatchewan Liquor and Gaming Authority spend in the 2002-2003 fiscal year on freight costs to ship alcohol to each of the 81 SLGA-operated liquor stores in Saskatchewan?

Answer:

In fiscal 2002-2003 Saskatchewan Liquor and Gaming Authority (SLGA) spent \$489,541 on freight to SLGA stores. This freight would include combined shipments of alcohol, allied products and stationery.

Mr. Dearborn asked the Government Question No. 72, which was answered by the Premier:

To the Premier: Will the Premier ensure that men and women of Saskatchewan serving in the Canadian Armed Forces in theatres of conflict such as Afghanistan, Bosnia, Haiti and the HMCS Toronto serving in the Persian Gulf receive full income tax exemption similar to federal income tax exemptions for such persons?

Answer:

The March 23, 2004 federal budget announced that for the 2004 and subsequent taxation years, a deduction be allowed in computing taxable income for members of the Canadian Forces or a Canadian police force in respect of employment income earned in a high-risk deployed operational mission as described in the budget documents tabled by the Minister of Finance in the House of Commons on March 23, 2004.

The Saskatchewan personal income tax system is linked to the federal income tax system and administered on the Province's behalf by the federal government. This linkage provides a common definition of income for tax purposes. The Province therefore, accepts the federal government's policies on income inclusions and deductions and provincial income tax must be calculated as a percentage of 'Taxable Income', after allowing for federally defined deductions from 'Total Income'.

As a result, Saskatchewan's income tax system will automatically ensure that those persons having employment income exempt from federal income tax will likewise have their employment income exempt from Saskatchewan income tax.

(2) \$504,492 in commissions on advertising placed with media outlets. (This is the same \$504,492 included in the preceding answer.) No commissions were paid for work done by third-party suppliers.
