# **QUESTIONS AND ANSWERS**

#### Mr. Elhard asked the Government Question No. 272, which was answered by the Hon. Mr. Forbes:

To the Minister of Environment: In fiscal year 2002-2003, how much money in grants, financial assistance and/or donations in kind did the Environment Department give to Ducks Unlimited and the Nature Conservancy of Canada?

Answer:

- In fiscal year 2002-2003, Saskatchewan Environment provided to:
- (1) Ducks Unlimited Canada \$60,754.00.
- (2) The Nature Conservancy of Canada no funding.
- **Mr. Elhard asked the Government Question No. 273, which was answered by the Hon. Mr. Forbes:** To the Minister of Environment: In fiscal year 2003-2004, how much money in grants, financial assistance and/or donations in kind will the Environment Department give to Ducks Unlimited and the Nature Conservancy of Canada?

#### Answer:

- In fiscal year 2003-2004, Saskatchewan Environment provided to:
- (1) Ducks Unlimited Canada no funds from its appropriation.
- (2) The Nature Conservancy of Canada no funds from its appropriation.

# Mr. Dearborn asked the Government Question No. 274, which was answered by the Hon. Ms. Crofford:

To the Minister of Community Resources and Employment: (1) Does the \$4.60 budget per person for food in community care homes for clients with disabilities suffice to provide each individual proper calorie intake and nutritional requirements as outlined by Health Canada? (2) Are there ratios for economies of scale? (3) What is the minimum number of clients required for this per capita allocation without adjustment?

#### Answer:

- (1) Yes (based on 4 people Health Canada's National Nutritious Food Basket). The Department developed a policy in 2004-05 to provide funding to offset the cost of physician-ordered special diets for individuals in group homes. This is expected to help alleviate some of the pressures on agency budgets related to exceptional food costs.
- (2) Funding rates/person are not adjusted in relation to number of individuals living in each home.
- (3) The rate per person is not adjusted to group home size.
