# **QUESTIONS AND ANSWERS**

# Mr. Hermanson asked the Government Question No. 315, which was answered by the Hon. Mr. Sonntag:

To the Minister Responsible for Saskatchewan Telecommunications: As of December 31, 2003: (1) How many MAX TV subscribers were not employees of SaskTel and received a discounted subscription rate for the MAX TV service? (2) How much was the discount per subscriber? (3) What qualification enabled the subscriber to receive a discount?

#### Answer

- (1) Currently, the discount on the TV component of Basic MAX applies only to SaskTel employees.
- (2) Not applicable.
- (3) Not applicable.

## Mr. Morgan asked the Government Question No. 316, which was answered by the Hon. Mr. Quennell:

To the Minister of Justice: (1) Can the Minister provide the number of judge positions that are currently available in each level of court? (2) How many judges have gone supernumerary?

#### Answer:

- (1) Provincial Court
  - 45 plus Chief Judge and Associate Chief Judge = 47 judge positions (1 vacancy)
  - There are 11 retired Provincial Court judges and four lawyers who have been appointed as temporary judges. Temporary judges fill in for regular judges to cover leaves.

Queen's Bench

- 32 plus Chief Justice = 33 judge positions (2 vacancies)
- Court of Appeal
- 8 plus Chief Justice = 9 judge positions (1 vacancy)
- (2) Provincial Court
  - Provincial Court judges do not have the option to elect supernumerary status.
